THE PROJECT

Jharkhand Tourism Development Corporation Limited (JTDC) intends to appoint an entity *for a period of ten years* to undertake renovation, operation and maintenance of 17(Seventeen) Tourism Properties at Jharkhand on Renovate, Operate, Maintain and Transfer (ROMT) Basis as per the details given in RFP Document (the “**Project**”).

ABOUT THE BIDDING

JTDC invites proposals from competent entity(ies) in accordance with the Request for Proposal (RFP) Document. The Bidding Document may be purchased from the office of JTDC at the address mentioned above on payment of a non-refundable fee of Rs.5000/- (Rupees Five Thousand Only), in the form of Demand Draft in favour of the Jharkhand Tourism Development Corporation Limited drawn on any Nationalized/ Scheduled bank, payable at Ranchi, Jharkhand. The Bidding Document may also be downloaded from the website www.jharkhandtenders.gov.in. A Bid Security for an amount as specified in the RFP document with respect to each tourism property for which the Bidder is intending to submit the Proposal should be submitted either in the form of demand draft or bank guarantee acceptable to JTDC.

A Pre-Proposal meeting will be held on 29th September, 2015 at 1130 hours at the above mentioned address of JTDC. The last date and time for submission of Proposals (Proposal Due Date) is 16th October, 2015 upto 1500 hours IST. All notifications, changes and amendments to the RFP will be posted only on the aforesaid website.

The Tender Inviting Authority reserves the right to accept or reject any or all the tenders to be received without assigning any reasons thereof.

1. INTRODUCTION

1.1 Background

1.1.1 The Jharkhand Tourism Development Corporation Limited (the “**Authority**” or “**JTDC**”) is a nodal agency under the Department of Tourism, Government of Jharkhand with a mandate to develop tourism infrastructure in the State of Jharkhand. JTDC is been operating various hotels, tourist complexes/bhawan and tourist information centres in the State of Jharkhand for providing accommodation to the tourists and dissemination of information. As part of this endeavour, the Authority intends to undertake renovation of 17(Seventeen) Tourism Properties at various places in Jharkhand as listed out in the table below on Public Private Partnership (PPP) (“**PPP**”) mode by entrusting the same to a competent entity(ies) under on Renovate, Operate, Maintain and Transfer (the “**ROMT**”) Basis for a period of 10 (ten) years (“**Project**”). A brief description of the project may be seen in the Project Information Memorandum (PIM) provided as Volume III of this Bidding Document.

The said 17(Seventeen) tourism properties have been classified under 3 (three) different categories. Tourism Property comprising of Tourist Information Centre is categorised as category I (“**Category I**”), Tourism Properties comprising of Wayside Amenities/Sanskar Bhawan/Restaurant is categorised as category II (“**Category II**”) and Tourism Properties comprising of Tourist Complex/Hotel is categorised as category III (“**Category III**”), [Category I, II and Category III are hereinafter referred to as (“**Categories**”)].

NOTE:

- A) This RFP document is common for all the tourism properties as provided in the above table. It may be noted, however, that for all intents and purposes the tourism properties are independent of each other and are to be bid for separately, in accordance with this RFP document, and separate PDMA have to be entered into for each tourism property.
- B) Bidder can submit its Proposal for any one or more than one Tourism Property. The submission of the Bidder shall be considered only for that tourism property (ies), for which the Bidder has explicitly submitted its Proposal.
- C) Bidder who meets the Technical and Financial Capacity criteria as set out in this RFP document shall be qualified for opening of its Financial Proposal for all the tourism property and on fulfilling the required Financial Capacity criteria as set out in Clause 2.1.1 (c), with respect to each of the Tourism property, shall be eligible to be awarded with a maximum of 4 (four) tourism properties.
- D) If the Bidder is currently operating and managing any one tourism property belonging to JTDC, such Bidder shall be eligible to be awarded with a maximum of 3 (three) tourism property only.
- E) If the Bidder is currently operating and managing any two tourism properties belonging to JTDC, such Bidder shall be eligible to be awarded with a maximum of 2 (two) tourism property only.
- F) If the Bidder is currently operating and managing any three tourism property belonging to JTDC, such Bidder shall be eligible to be awarded with a maximum of 1 (one) tourism property only.
- G) If the Bidder is currently operating & managing 4(four) tourism properties belonging to JTDC, such Bidder is not eligible to participate in this Bidding Process.

1.1.2 The Authority intends to select a suitable entity (“**Developer**”) through a competitive bidding process, who would implement the Project in accordance with the project development and

management agreement (the “**Project Development and Management Agreement**” or “**PDMA**”) to be entered into between the successful bidder and the Authority in the format provided as Volume II of the Bidding Documents pursuant hereto.

- 1.1.3 The scope of work will include renovation, operation, maintenance, management and transfer of the Project. Developer has the right to demand, charge, collect and retain the user fee from user’s of the Project and transfer the Project site along with the Project facilities to the Authority or its authorised representative upon expiry in accordance with the provisions of draft Project Development and Management Agreement.
- 1.1.4 The statements and explanations contained in this Request for Proposal are intended to provide a proper understanding to the Bidders about the subject matter of this RFP and should not be construed or interpreted as limiting in any way or manner the scope of services and obligations of the Developer set forth in the draft Project Development and Management Agreement or the Authority’s right to amend, alter, change, supplement or clarify the scope of work, the Project to be awarded pursuant to this RFP or the terms there of or herein contained. Consequently, any omissions, conflicts or contradictions in the Bidding Documents including this Volume-I Instruction to Bidders are to be noted, interpreted and applied appropriately to give effect to this intent, and no claims on that account shall be entertained by the Authority.
- 1.1.5 The Proposals would be evaluated on the basis of the evaluation criteria set out in this RFP document in order to identify the successful Bidder for the Project (“**Successful Bidder**”).
- 1.1.6 The Bidder is required to pay a non-refundable amount of Rs. 5000/- (Rupees Five Thousand Only) in the form of Demand Draft in favour of Jharkhand Tourism Development Corporation Limited , drawn on any Nationalized or a Scheduled Bank in India, payable at Ranchi, Jharkhand towards the cost of the Bidding Document and obtain the receipt of payment from the Authority. In case the Bidder has downloaded the Bidding Document from the Authority’ website, the Bidder is required to submit the Demand Draft to the office of the Authority along with the Technical Proposal in the manner set out in Clause 2.13.1 of this RFP document.

1.2 Brief Description of Bidding Process

- 1.2.1 The Authority has adopted a single stage bidding process (the **Bidding Process**) for award of the Project in accordance with the terms of this RFP and invites proposals (Proposal) from eligible entities which expression shall, unless repugnant to the context include the members of the Consortium (“**Bidders**”), for the Project in accordance with the terms of this RFP
- 1.2.2 The Bidders are requested to submit their Proposals in accordance with the RFP Document. The Proposal shall be valid for a period of not less than 180 (one hundred and Eighty) days from the date specified in Clause 1.3 for submission of Proposals (the “**Proposal Due Date**”).
- 1.2.3 The Bidding Documents include the Request for Proposal comprising Instruction to Bidder (ITB), the draft Project Development and Management Agreement and the Project Information Memorandum for the Project (collectively the “**Bidding Documents**”). The

Bidding Documents and any addenda issued subsequent to this RFP, but before the Proposal Due Date, will be deemed to form part of the Bidding Documents.

- 1.2.4 The Bidders are required to deposit, along with its Proposal, a bid security for an amount specified in the table below with respect to the tourism property for which the Bidder is intending to submit its Proposal (“**Bid Security**”) either in the form of demand draft issued by a Scheduled Bank in India, drawn in favour of Jharkhand Tourism Development Corporation Limited, payable at Ranchi, Jharkhand (the “**Demand Draft**”) or in the form of a bank guarantee acceptable to Authority. The validity period of the demand draft or bank guarantee shall not be less than 180 days from the Proposal Due Date, inclusive of a claim period of 60 (sixty) days, and may be extended as may be mutually agreed between the Authority and the Bidder from time to time, except in the case of the Successful Bidder whose Bid Security shall be retained till it has provided a Performance Security under the PDMA. The Proposal shall be summarily rejected if it is not accompanied by the Bid Security.

1.2.5 Bidders are invited to examine the Project in detail, and to carry out, at their cost, such studies as may be required for submitting their Proposal for award of the Project. The Project Information Memorandum (PIM) comprising details of the project site and the existing facilities therein is provided as Volume III. PIM is being provided only as a preliminary reference document to the Bidders for information. Bidders are expected to carry out their own surveys, investigations and other detailed examination of the Project before submitting their Proposals. Nothing contained in the PIM shall be binding on the Authority nor confers any right on the Bidders, and the Authority shall have no liability whatsoever in relation to arising out of any or all contents of the PIM.

1.2.6 Bidders would need to submit the following sets of documents (one original and two copies) as part of their Proposal.

- a. “**Technical Proposal**” comprising the documents specified in Clause 2.13.2 and
- b. “**Financial Proposal**” in the format provided at **Appendix I**. The Financial Proposal shall clearly indicate the amount in both figures and words, in Indian Rupees.

1.2.7 Financial Proposal are invited for the Project on the basis of the annual fee (“**Annual Fee**”) to be offered by a Bidder for implementing the Project. The Annual Fee shall constitute the sole criteria for evaluation of Financial Proposals. The Project will be awarded to the Bidder quoting the highest Annual Fee for undertaking the Project.

In this RFP, the term “**Highest Bidder**” shall mean the Bidder who is offering the highest Annual Fee to the Authority.

The Authority has fixed minimum annual fee to be quoted by the Bidder [the “**Minimum Annual Fee**”] with respect to the tourism property for which the Bidder is intending to submit its Proposal as provided in the table below:

Note:

- i. The Bidder should quote the Annual Fee above the Minimum Annual Fee with respect to each tourism property for which the Bidder is intending to submit its Proposal. Only the Financial Proposal which is above the Minimum Annual Fee shall be considered for evaluation. The Authority shall reject all the Proposals being less than the Minimum Annual Fee. The highest Annual Fee shall constitute the sole criteria for evaluation of the Financial Proposal.
- ii. The Annual Fee offered by the Successful Bidder shall be payable to the Authority from the 2nd (second) anniversary of execution of the Project Development and Management Agreement and shall be escalated by 10% (ten Percent) once in every two years throughout the Agreement Period as per the terms of Project Development and Management Agreement.
- iii. The Annual Fee is exclusive of Service Tax & all other applicable taxes and shall be payable by the Developer at actual over and above the Annual Fee. The Annual Fee shall be payable to the Authority, on or before 30 (thirty) days prior to the start of the year.

- iv. The Developer should pay the Annual Fee to the Authority notwithstanding the fact that, the renovation of Project facilities is not completed within the specified period or Developer does not start the commercial operation of the Project. In other words, The Developer shall not be entitled to seek any reduction of Annual Fee, claim, damages, compensation or any other consideration from the Authority on account of any reason.

1.2.8 The details of the process to be followed in the Bidding Process and the terms thereof are spelt out in this RFP.

2. INSTRUCTIONS TO BIDDERS

A. General

2.1 Eligible Bidders

2.1.1 For determining the eligibility of the Bidders, the following conditions are required to be satisfied (the “**Qualification Criteria**”):

- (a) The Bidder for participating in the Bidding Process may be a single business entity (the “**Single Business Entity**”) or a group of single business entities (the “**Consortium**”), coming together to implement the Project. The term Bidder used herein would apply to a single business entity or a Consortium.

For the purpose of this RFP document, Single Business Entities shall mean a company incorporated under the Companies Act, 1956 or a partnership firm registered under the Indian Partnership Act, 1932 or any combination of the above with a formal intent to enter into an agreement or under an existing agreement to form a Consortium. A Consortium shall be eligible for consideration subject to the conditions set out in Clause 2.1.3 below.

Note:

If the Bidder is:

- i. A company, it should furnish copy of the certificate of incorporation and memorandum of association as a proof of identity.
 - ii. A registered partnership firm, it should furnish a copy of the IT returns for the last three financial years preceding the Proposal Due Date copy of the registration certificate under the registrar of firms and a copy of the partnership deed executed between the partners as a proof of identity
- (b) The Bidder should demonstrate the following technical capacity (the “**Technical Capacity**”) with respect to the tourism property for which the Bidder is intending to submit its Proposal:

- (c) The Bidder should demonstrate the financial capability (the “**Financial Capacity**”) of having a minimum Net worth as at the close of the financial year preceding the Proposal Due Date i.e 2014-15 and the minimum Average Annual Turnover over a period of 3 (three) completed Financial years preceding the Proposal Due Date i.e 2014-15, 2013-14 and 2012-13 with respect to each of the tourism property for which the Bidder is intending to submit its Proposal as provided in the table below.

Note:

1. In case the Bidder is a Consortium, the Financial Capacity of both the Lead Member as well as the Other Member shall be considered for the purpose of evaluation of Financial Capacity.

2. Financial Capacity of parent/subsidiary/associate company (ies) of the Bidder would not be considered for evaluation.
 3. For demonstrating the Financial Capacity, the Bidder is required to submit
 - i) Audited annual financial statements of the Bidder for the financial year immediately preceding the Proposal Due Date.
In case the annual accounts for the latest financial year are not audited and therefore the Bidder could not make it available, the Bidder shall give an undertaking to that effect and the statutory auditor shall certify the same. In such a case, the Bidder may provide the unaudited Annual Accounts (with Schedules) for the latest financial year. In any case, the Audited Annual Financial Statements for the year preceding the latest financial year would have to be provided, failing which the Proposal will be rejected as non-responsive and
 - ii) Certificate from a Statutory Auditor in the format provided at Appendix D.
 - iii) In case of a Partnership firm, if the audited annual financial statements of the Bidder for the financial year immediately preceding the Proposal Due Date is not available, a certificate from the Chartered Accountant certifying the Networth along with the certificate from the valuator with regard to the Land and Building is required to be submitted. Failure to do so would be considered as a non-responsive Proposal
- 2.1.2 The Bidder should submit a Power of Attorney as per the format enclosed as **Appendix E**, authorising the signatory of the proposal to commit the member thereof. In case the Bidder is submitting its Proposal as a Consortium, the Bidder should submit the Power of Attorney in favour of the Lead Member as per the format enclosed as **Appendix F**.
- 2.1.3 Proposals submitted by a Consortium should comply with the following additional requirements:
- (a) The Proposal should contain the information required from each member;
 - (b) The Proposal should include a description of the roles and responsibilities of the members;
 - (c) The number of members in a Consortium would be limited to 3 (three) members, one of whom shall be designated as a Lead Member (the “**Lead Member**”) and other as Other Member;
 - (d) A Bidder who has applied for a Project in its individual capacity or as part of a Consortium cannot participate as a member of any other Consortium applying for the Project;
 - (e) The members of the Consortium shall execute a Power of Attorney as per the format enclosed at **Appendix F**.
 - (f) The members of the Consortium shall enter into a Joint Bidding Agreement (“**Jt. Bidding Agreement**”) and submit the same with the Proposal.
The Joint Bidding Agreement should, inter alia:
 - (i) convey the intent of the members of the Consortium to enter into the Agreement in case the Project is awarded to the Consortium.
 - (ii) The Lead Member would enter into the Agreement with JTDC on behalf of the members of the Consortium and subsequently carry out all the responsibilities in terms of the Agreement;

- (iii) clearly outline the proposed roles and responsibilities of each member of the Consortium; and
- (iv) include a statement to the effect that the members of the Consortium shall be jointly and severally liable for the implementation of the Project in accordance with the terms of the Agreement.

(Note: A copy of the Joint Bidding Agreement should be submitted along with the Proposal as per format provided in **Appendix H**. The Joint Bidding Agreement entered into between the members of the Consortium should be specific to Project and should fulfil the above requirements, failing which the Proposal shall be considered non-responsive).

2.1.4 A Bidder shall not have a conflict of interest (the “**Conflict of Interest**”) that affects the Bidding Process. Any Bidder found to have a Conflict of Interest shall be disqualified. In the event of disqualification, the Authority shall forfeit and appropriate the Bid Security or Performance Security, as the case may be, as mutually agreed genuine loss and damages likely to be suffered and incurred by the Authority and not by way of penalty for, inter alia, the time, cost and effort of the Authority, including consideration of such Bidder’s Proposal submission, without prejudice to any other right or remedy that may be available to the Authority hereunder and/ Project Development and Management Agreement or otherwise. Without limiting the generality of the above, a Bidder shall be considered to have a Conflict of Interest that affects the Bidding Process, if:

- a. such Bidder, its Member (or any constituent thereof) and any other Bidder, its Member (or any constituent thereof) have common controlling shareholders or other ownership interest; provided that this qualification shall not apply in cases where the direct or indirect shareholding in a Bidder, its Members or a constituent thereof in the other Bidder(s) (or any of its constituents) is less than 26% of its paid up and subscribed capital; or
- b. a constituent of such Bidder is also a constituent of another Bidder; or
- c. such Bidder has the same legal representative for purposes of this Bid as any other Bidder; or
- d. such Bidder has a relationship with another Bidder, directly or through common third parties, that puts them in a position to have access to each others’ information about, or to influence the Bid of either or each of the other Bidder; or
- e. such Bidder has participated as a consultant to the Authority in the preparation of any documents, design or technical specifications of the Project.

2.1.5 Any entity, which has earlier been barred by the Authority or Government of Jharkhand from participating in its projects, would not be eligible to submit a Proposal, either individually or as member of a Consortium if such bar subsists as on the Proposal Due Date.

2.1.6 The following conditions shall be adhered to while submitting a Bid:

- a. Bidders should attach clearly marked and referenced continuation sheets in the event that the space provided in the prescribed forms in the Annexes to Appendices is insufficient. Alternatively, Bidders may format the prescribed forms making due provision for incorporation of the requested information;

- b. information supplied by a Bidder (or other constituent Member if the Bidder is a Consortium) must apply to the Bidder or Member named in the Bid and not, unless specifically requested, to other associated companies;
- c. Bidders should demonstrate their Qualification Criteria in accordance with Clause 2.1.1 of this RFP; and
- d. In case the Bidder is a Consortium, each Member should substantially satisfy the qualification requirements to the extent specified herein.

2.2 Change in Composition of the Bidder

- 2.2.1 Change in the composition of a Consortium will not be permitted by the Authority.
- 2.2.2 By submitting the Proposal, the Bidder shall also be deemed to have acknowledged and agreed that in the event of a change in control of a Consortium Member whose Technical Capacity and/ or Financial Capacity was taken into consideration for the purposes of qualification under and in accordance with the RFP, the Bidder shall inform the Authority forthwith along with all relevant particulars about the same and the Authority may, in its sole discretion, disqualify the Bidder or withdraw the LOA from the Successful Bidder, as the case may be. In the event such change in control occurs after signing of the Project Development and Management Agreement, it would, notwithstanding anything to the contrary contained in the Project Development and Management Agreement, be deemed to be a breach thereof, and the Project Development and Management Agreement shall be liable to be terminated without the Authority being liable in any manner whatsoever to the Developer. In such an event, notwithstanding anything to the contrary contained in the Project Development and Management Agreement, the Authority shall forfeit and appropriate the Bid Security or Performance Security as the case may be, as mutually agreed genuine compensation and damages payable to the Authority for, inter alia, time, cost and effort of the Authority, without prejudice to any other right or remedy that may be available to the Authority hereunder or otherwise.

2.3 Number of Proposals

- 2.3.1 Each Bidder shall submit only one (1) Proposal with respect to Tourism Property for which the Bidder is intending to submit its Proposal, in response to this RFP. Any Bidder, who submits more than one Proposal, will be disqualified and will also cause the disqualification of the Consortium of which it is a member.
- 2.3.2 Under this RFP document, a Bidder may submit Proposals for more than one Tourism Property. Subject to Clause 2.3.3 below, a Bidder would be awarded a maximum of 2 (two) Tourism Properties. A Bidder submitting its Financial Proposal for more than one Tourism Property is required to submit a common Technical Proposal and submit separate Financial Proposal with respect to each Tourism Property for which the Bidder is intending to submit its Proposal. The Proposals would be evaluated on the basis of the evaluation criteria set out in Clause 2.1.1 (b) and (c) of this RFP document.

- 2.3.3 If the Bidder has submitted its Proposals for more than one Tourism Property and has already been selected as the Successful Bidder for any one Tourism Property, such Bidder(s) Financial Proposal for remaining Tourism Property(ies) would be opened by the Authority subject to the Bidder having the Residual Financial Capacity in respect of such Tourism Property.

For avoidance of doubt, no Bidder shall be eligible to get more than 4 (four) Tourism Properties under this RFP. In case the Bidder is currently operating and managing any one tourism property belonging to JTDC, such Bidder shall be eligible to be awarded with a maximum of 3 (three) tourism property only. In case the Bidder is currently operating and managing any two tourism properties belonging to JTDC, such Bidder shall be eligible to be awarded with a maximum of 2 (two) tourism property only. In case the Bidder is currently operating and managing any three tourism property belonging to JTDC, such Bidder shall be eligible to be awarded with a maximum of 1 (one) tourism property only. In case the Bidder is currently operating & managing 4(four) tourism properties belonging to JTDC, such Bidder is not eligible to participate in this Bidding Process.

2.4 Proposal Preparation Cost

The Bidder shall be responsible and shall pay for all of the costs associated with the preparation of its Proposal and its participation in the Bidding Process. The Authority will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.

2.5 Project Inspections and Visit to the Site

- 2.5.1 It is desirable that each Bidder submits its Proposal after visiting the site at their own cost and ascertaining for itself the location, surroundings, or any other matter considered relevant by it.
- 2.5.2 It would be deemed that by submitting the Proposal for RFP, the Bidder has:
- a. made a complete and careful examination of terms & conditions / requirements, and other information set forth in this RFP document;
 - b. received all such relevant information as it has requested from the Authority; and
 - c. made a complete and careful examination of the various aspects of the Project including but not limited to:
 - i. the site details (Project site);
 - ii. the conditions of the access roads and utilities in the vicinity of the Project Site;
 - iii. conditions affecting transportation, access, disposal, handling and storage of materials;
 - iv. clearances obtained by the Authority for the Project;
 - v. Business potential of proposed project;
 - vi. Extent of land in actual possession of the Authority and deviations if any, irrespective of the extent of deviation, from the extent of land details mentioned in this RFP document; and
 - vii. all other matters that might affect the Bidder's performance under the terms of this RFP document.

2.5.3 The Authority shall not be liable for any mistake or error on the part of the Bidder in respect of the above.

2.6 Right to Accept or Reject any of the Proposals

2.6.1 Notwithstanding anything contained in this RFP, the Authority reserves the right to accept or reject any Proposal and to annul the Bidding Process and reject all Proposals at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons therefore. In the event the Authority rejects or annuls all the Proposals, it may, in its discretion, invite all eligible Bidders to submit fresh Proposals hereunder.

2.6.2 The Authority reserves the right to reject any Proposal and appropriate the Bid Security if:

- a. at any time, a material misrepresentation is made or uncovered, or
- b. the Bidder does not provide, within the time specified by the Authority, the supplemental information sought by the Authority for evaluation of the Proposal.

Such misrepresentation/improper response shall lead to the disqualification of the Bidder. If the Bidder is a Consortium, then the entire Consortium shall be disqualified/rejected. If such disqualification/rejection occurs after the Proposals have been opened and the Highest Bidder gets disqualified/rejected, then the Authority reserves the right to:

- (i) invite the remaining Bidders to match the Highest Bidder/submit their Proposals in accordance with the RFP; or
- (ii) take any such measure as may be deemed fit in the sole discretion of the Authority, including annulment of the Bidding Process.

2.6.3 In case it is found during the evaluation or at any time before signing of the Draft PDMA or after its execution and during the period of subsistence thereof, including the right thereby granted by the Authority, that one or more of the qualification conditions have not been met by the Bidder or the Bidder has made material misrepresentation or has given any materially incorrect or false information, the Bidder shall be disqualified forthwith if not yet appointed as the Successful Bidder either by issue of the LOA or execution of the PDMA, and if the Bidder has already been issued the LOA or has entered into the PDMA, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by the Authority to the Bidder, without the Authority being liable in any manner whatsoever to the Bidder or Successful Bidder, as the case may be. In such an event, the Authority shall forfeit and appropriate the Bid Security or Performance Security, as the case may be, as mutually agreed genuine compensation and damages payable to the Authority for, inter alia, time, cost and effort of the Authority, without prejudice to any other right or remedy that may be available to the Authority.

2.6.4 The Authority reserves the right to verify all statements, information and documents submitted by the Bidder in response to the RFP. Failure of the Authority to undertake such

verification shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of the Authority thereunder.

2.7 Clarification and Amendment of RFP

- 2.7.1 Interested Bidder requiring any clarification on the RFP document may notify to the Authority to the address specified in Clause 1.3 before the last date of receiving queries mentioned in Clause 1.3, Schedule of Bidding Process in writing or by fax and e-mail to the below address. The envelopes/ communication shall clearly bear the following identification/ title:

Queries/Request for Additional Information: RFP for “Selection of a Developer for Development of Tourism Properties at Jharkhandon Renovate, Operate, Maintain and Transfer (ROMT) Basis”.

- 2.7.2 At any time prior to the Proposal Due Date, the Authority may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the RFP Document by the issuance of Addenda. Any Addendum or responses issued hereunder will be uploaded on the Authority website viz. www.jharkhandtenders.gov.in or sent by courier post and/or fax and /or email without identifying the source of queries and the published details shall be binding on the participating Bidders.
- 2.7.3 In order to provide the Bidders a reasonable time to examine the Addendum, or for any other reason, the Authority may, at its own discretion, extend the Proposal Due Date. Information about extension of the Proposal Due Date will be published on Authority website www.jharkhandtenders.gov.in or sent by courier post and/or fax and /or email.

C. Preparation and Submission of Proposal

2.8 Language

- 2.8.1 The Proposal and all related correspondence and documents should be written in the English language. Supporting documents and printed literature furnished by Bidder with the Proposal may be in any other language provided that they are accompanied by appropriate translations in English language duly certified by a competent person (Statutory Auditor, Company Secretary, Director of the Company). Supporting materials, which are not translated into English, will not be considered. For the purpose of interpretation and evaluation of the Proposal, the English language translation shall prevail.

2.9 Bid Security

- 2.9.1 The Bidder should submit as part of its Proposal a Bid Security for an amount with respect to the tourism property for which the Bidder is intending to submit its Proposal in the manner set out in Clause 1.2.4 of the RFP document.
- 2.9.2 The Authority shall not be liable to pay any interest on the Bid Security so made and the same shall be interest free. The validity period of the Demand Draft or the Bank Guarantee shall not be less than 180 (one hundred and eighty) days from the Proposal Due Date, inclusive of a

claim period of 60 (sixty) days, and may be extended as may be mutually agreed between the Authority and the Bidder.

- 2.9.3 The Bid Security shall be returned to the unsuccessful Bidders not later than 60(sixty) days from the date of announcement of the Successful Bidder. The Bid Security submitted by the Successful Bidder shall be released on submission of Performance Security and signing of the PDMA. Where Bid Security has been paid by Demand Draft, the refund thereof shall be in the form of an account payee demand draft in favour of the unsuccessful Bidder(s). Bidders may by specific instructions in writing to the Authority give the name and address of the person in whose favour the said demand draft shall be drawn by the Authority for refund, failing which it shall be drawn in the name of the Bidder and shall be mailed to the address given on the Proposal.
- 2.9.4 The Bid Security shall be forfeited in the following cases:
- a. If the Bidder modifies or withdraws its Proposal except as provided in Clause 2.16.
 - b. If the Bidder withdraws its Proposal during the interval between the Proposal Due Date and expiration of the Proposal Validity Period.
 - c. If any information or document furnished by the Bidder turns out to be misleading or untrue in any material respect.
 - d. If a Bidder engages in a corrupt or undesirable practices;
 - e. In the case the Successful Bidder, fails within the specified time limit to:
 - i. sign and return the duplicate copy of LoA;
 - ii. sign the PDMA with the Authority; or
 - iii. furnish the Performance Security within the prescribed period.

2.10 Validity of Proposal

Proposal shall remain valid for a period not less than 180 (One Hundred and Eighty) days from the Proposal Due Date ("**Proposal Validity Period**"). The Authority reserves the right to reject any Proposal, which does not meet this requirement.

2.11 Extension of Validity of Proposal

- 2.11.1 In exceptional circumstances, prior to expiry of the original Proposal Validity Period, the Authority may request Bidders to extend the Proposal Validity Period for a specified additional period.
- 2.11.2 A Bidder may refuse the request without forfeiting its Bid Security. A Bidder agreeing to the request will not be allowed to modify its Proposal, except as provided under Clause 2.16 but would be required to extend the validity of its Bid Security for the period of extension.
- 2.11.3 The Successful Bidder shall, where required, extend the Proposal Validity Period till the date of execution of the PDMA.

2.12 Format and Signing of Proposal

- 2.12.1 Bidders should submit the Technical Proposal and the Financial Proposal in the manner set out in this Clause 2.12. The Authority would evaluate only those Proposals that are received in the required format and complete in all respects. Incomplete and/or conditional Proposals shall be liable to rejection.
- 2.12.2 Bidders shall prepare one original set of the Proposal (together with originals/ two copies of documents required to be submitted along therewith pursuant to this RFP) and clearly mark as “**ORIGINAL**”. In addition, the Bidder shall submit 2 (two) copies of the Proposal, along with Documents required to be submitted along therewith pursuant to this RFP, mark as “**COPY 1**” and “**COPY 2**”. In the event of any discrepancy between the original and the two copies, the original shall prevail.
- 2.12.3 The Proposal shall be typed or written in indelible ink and signed by the Authorized Representative (the “**Authorized Representative**”) of the Bidder who shall also initial each page, in blue ink. In case of printed and published Documents, only the cover shall be initialled. The person signing the Proposal shall initial all the alterations, omissions, additions, or any other amendments made to the Proposal. The Proposals must be properly signed by the Authorized Representative as detailed below:
- (a) by a duly authorized person holding the Power of Attorney, in case of a Company; or
 - (b) by the partner or a duly authorized person holding the Power of Attorney, in case of a partnership firm.
- 2.12.4 A copy of the Power of Attorney certified by the authorized signatory of the Bidder in the form specified in Appendix E should accompany the Proposal.

2.13 Sealing and Marking of Proposals

- 2.13.1 The Bidder shall submit all the documents sought under the RFP, together with the documents mentioned in Clause 2.14.2 in the format provided under the RFP and in the manner specified in Clause 2.14.2.
- 2.13.2 The Bidder shall submit the Proposal in two separate envelopes comprising the following documents and marked as “**Original Technical Proposal**” and “**Original Financial Proposal**”

Envelope 1- “Technical Proposal” comprising the following documents:

- a. Covering Letter-cum-Project Undertaking, clearly stating the validity of the Proposal as per format at **Appendix A**;
- b. Details of Bidder as per the format at **Appendix B** along with supporting documents as specified therein;
- c. Technical Capacity of the Bidder as per the format at **Appendix C** along with Statutory Auditor certificate and supporting documents as specified therein;
- d. Financial Capability of the Bidder as per the format at **Appendix D** along with Statutory Auditor certificate and supporting documents as specified therein;
- e. Power of Attorney for Signing of Proposal as per the format at **Appendix E**;

- f. Power of Attorney for Lead Member of Consortium, if any, as per the format at Appendix F;
- g. Bid Security either in the form of demand draft issued by a Scheduled Bank in India, drawn in favour of Jharkhand Tourism Development Corporation Limited and payable at Ranchi, Jharkhand or through a Bank Guarantee acceptable to the Authority for an amount specified in Clause 1.2.4 of this RFP in the format at Appendix G;
- h. Jt. Bidding Agreement, in case of a Consortium substantially in the format at Appendix H;
- i. In case of a company, it should furnish copy of the certificate of incorporation and memorandum of association as a proof of identity.
- j. In case of a registered partnership firm, it should furnish a copy of the IT returns for the last three financial years preceding the Proposal Due Date copy of the registration certificate under the registrar of firms and a copy of the partnership deed executed between the partners as a proof of identity
- k. Copy of the payment receipt from the Authority in case the Bidding Document is purchased from Authority's office or in case the document is downloaded from the Authority's website www.jharkhandtenders.gov.in, copy of the demand draft of Rs.5000/- (Rupees Five Thousand Only) in favour of Jharkhand Tourism Development Corporation Limited, payable at Ranchi, Jharkhand towards the cost of the Bidding Document and
- l. A copy of the entire Bidding document (along with the addendum, if any) duly signed on each page by the authorised signatory of the Bidder. The Bidding Document shall also have Bidders stamp on each page along with signature of the authorised representative of the Bidder.

Envelope 2- "Financial Proposal"

The Financial Proposal consisting of the Bidders financial offer for the Project shall be submitted in the prescribed format **Appendix – I** on the letter head of the Bidder and signed by the Authorised Representative.

NOTE:

1. Bidder intending to submit its Proposal for any one of the tourism property shall submit:
 - a. One set of Technical Proposal
 - b. Bid Security and one Financial Proposal in the format prescribed at Appendix I for the tourism property for which the Bidder is intending to submit the Proposal.
2. Bidders intending to submit Proposals for more than one tourism property (ies) shall submit:
 - a. One set of Technical Proposal
 - b. Separate Bid Security for an amount specified in Clause 1.2.4 and Separate Financial Proposal in the format prescribed at Appendix I for each tourism property for which the Bidder is intending to submit its Proposal.

2.13.3 The copy of the above documents shall also be placed in two separate envelopes and marked as "Copy 1 -Technical Proposal" and "Copy- 1 Financial Proposal" and "Copy 2 - Technical Proposal" and "Copy- 2 Financial Proposal".

2.13.4 The sixenvelopes specified in 2.13.3 above shall be placed in an outer envelope, which shall be sealed and clearly bear the following identification:

“Proposal for Selection of a Developer for Development of Tourism Properties at Jharkhand on Renovate, Operate, Maintain and Transfer (ROMT) Basis”

and shall also clearly indicate the name and address of the Bidder. In addition, the Proposal Due Date should be indicated on the right hand top corner of each of the envelope.

2.13.5 The envelopes shall be addressed to:

2.13.6 If the envelopes are not sealed and marked as instructed above, the Authority assumes no responsibility for the misplacement or premature opening of the contents of the Proposal submitted and consequent losses, if any, suffered by the Bidder.

2.13.7 Proposals submitted by fax, telex, telegram or e-mail shall not be entertained and shall be rejected.

2.14 Proposal Due Date

2.14.1 The Bidder should submit the Technical Proposal and Financial Proposal on or before 1500hours IST on the Proposal Due Date, at the address provided in Clause 2.13.5 in the manner and form as detailed in this RFP. Proposals submitted by either facsimile transmission or telex will not be acceptable.

2.14.2 The Authority may at its sole discretion, extend the Proposal Due Date by issuing an Addendum in accordance with Clause 2.7 uniformly for all Bidders.

2.15 Late Proposals

Any Proposal received by the Authority after the time mentioned in Clause 2.14 shall not be eligible for consideration and shall be summarily rejected.

2.16 Modifications/ Substitution/ Withdrawal of Proposals

2.16.1 Bidder may modify, substitute or withdraw its Proposal prior to the Proposal Due Date by written notice of the modification, substitution or withdrawal to the Authority. No Proposal shall be modified, substituted or withdrawn by the Bidder after the Proposal Due Date.

- 2.16.2 The modification, substitution or withdrawal notice shall be prepared, sealed, marked, and delivered in accordance with Clause 2.13, with the envelopes being additionally marked “MODIFICATION”, “SUBSTITUTION” or “WITHDRAWAL”, as appropriate.
- 2.16.3 Any alteration/ modification in the Proposal or additional information supplied subsequent to the Proposal Due Date, unless the same has been expressly sought for by the Authority, shall be disregarded.

2.17 Pre-Proposal Meeting

- 2.17.1 To clarify and discuss issues with respect to the Project and the RFP, the Authority may hold Pre-Proposal meeting(s).
- 2.17.2 Prior to the Pre-Proposal meeting(s), the Bidders may submit a list of queries, if any, on the Project requirements and/or the PDMA. Bidders must formulate their queries and forward the same to the Authority as per RFP Time Schedule prior to the meeting. The Authority may, in its sole discretion or based on inputs provided by Bidders that it considers acceptable, amend the RFP.
- 2.17.3 The Authority will endeavour to hold the Pre-Proposal meeting(s) as specified in Clause 1.3 of the RFP Document.
- 2.17.4 Attendance of the Bidders at the Pre-Proposal meeting is not mandatory. However, subsequent to the meeting(s), the Authority may not respond to queries from any Bidder.
- 2.17.5 All correspondence / enquiries should be submitted to the address provided in Clause 1.3, Schedule of Bidding Process in writing by fax/ registered post / courier.
- 2.17.6 No interpretation, revision, or other communication from the Authority regarding this solicitation is valid unless it is in writing and is signed by the Authority and the Authority will upload its responses in its website www.jharkhandtenders.gov.in or sent by courier post and/or fax and/or email including a description of the enquiry without identifying its source

2.18 Confidentiality

Information relating to the examination, clarification, evaluation, and recommendation for the Bidders shall not be disclosed to any person not officially concerned with the process. The Authority will treat all information submitted as part of Proposal in confidence and would require all those who have access to such material to treat the same in confidence. The Authority will not divulge any such information unless it is ordered to do so by any authority pursuant to applicable law or order of a competent court or tribunal, which requires its disclosure.

2.19 Clarifications

To assist in the process of evaluation of Proposals, the Authority may, at its sole discretion, ask any Bidder for clarification on its Proposal or substantiation of any of the submissions

made by the Bidder. The request for such clarification or substantiation and the response shall be in writing or by facsimile. No material change in the substance of the Proposal would be permitted by way of such clarification / substantiation.

2.20 Consultant(s) or Advisor(s)

To assist the Authority to carry out the Bidding Process, the Authority may appoint a consultants or advisors to act as the project advisors to undertake the project development activities inter-alia including preparation of Bidding Documents and selection of the Successful Bidder in terms thereof.

3. EVALUATION PROCESS

3.1 Evaluation Process

Proposals submitted shall be evaluated in the following 3 (three) steps.

- a. **Step 1-** The first step would involve opening of Technical Proposal and a test of responsiveness would be carried out as set out in Clause 3.2.1 of the RFP. Those Proposals found to be substantially responsive would be considered for the next step of evaluation.
- b. **Step 2-** In the second step, evaluation of the Bidders experience comprising Technical Capacity and Financial Capacity (“**Qualification Criteria**”) would be undertaken as per Clause 2.1.1 of the RFP document. Bidders who meet the qualification criteria would be considered as qualified bidders (the “**Qualified Bidders**”) and shall be considered for the next step of evaluation.
- c. **Step 3-** In the third step, the Financial Proposals of all the Qualified Bidders would be considered for opening. Bidder quoting the Highest Annual Fee in terms of the RFP document shall be declared as the Successful Bidder.

3.2 Tests of Responsiveness

3.2.1 Prior to evaluation of Proposals, the Authority will determine whether each Proposal is responsive to the requirements of the RFP. A Proposal shall be considered responsive if the Proposal:

- a. is received before the Proposal Due Date including any extension thereof pursuant to Clause 2.14.2.
- b. contains the payment receipt from the Authority in case the Bidding Document is purchased from Authority’s office or in case the document is downloaded from the Authority’s website www.jharkhandtenders.gov.in, contains copy of the demand draft of Rs.5000/- (Rupees Five Thousand Only) in favour of Jharkhand Tourism Development Corporation Limited, payable at Ranchi, Jharkhand towards the cost of the Bidding Document.
- c. contains the information, Bid Security and documents as requested in the RFP.
- d. contains information in formats specified in the RFP.
- e. mentions the validity period as set out in Clause 2.11.
- f. it is accompanied by the Jt. Bidding Agreement (for Consortium), specific to the Project, as stipulated in Clause 2.1.3 (e).
- g. it provides the information in reasonable detail. (“**Reasonable Detail**” means that, but for minor deviations, the information can be reviewed and evaluated by the Authority without communication with the Bidder). The Authority reserves the right to determine whether the information has been provided in reasonable detail.
- h. there are no inconsistencies between the Proposal and the supporting documents.

3.2.2 A Proposal that is substantially responsive is one that conforms to the preceding requirements without material deviation or reservation. A material deviation or reservation is one which,

- a. affects in any substantial way, the scope, quality, or performance of the Project, or
- b. limits in any substantial way, inconsistent with the RFP document, the Authority 's rights or the Bidder's obligations under the PDMA, or
- c. unfairly affects the competitive position of other Bidders presenting substantially responsive Proposals.

3.2.3 Bidders may note that the Authority will not entertain any deviations to the RFP at the time of submission of the Proposal or thereafter. The Proposal to be submitted by the Bidders would have to be unconditional and unqualified and the Bidders would be deemed to have accepted the terms and conditions of the RFP with all its contents including the Draft PDMA. Any conditional Proposal shall be regarded as non-responsive and would be liable for rejection.

3.2.4 The Authority reserves the right to reject any Proposal which is non-responsive and no request for alteration, modification, substitution or withdrawal shall be entertained by the Authority in respect of such Proposals.

3.3 Evaluation of Qualification Criteria

3.3.1 The Proposals of the Bidders which are found to be responsive as above shall be evaluated to ensure that the Proposals meets the Qualification Criteria specified in Clause 2.1.1.

3.3.2 Bidders are advised that selection of Bidders will be entirely at the discretion of the Authority. Bidders will be deemed to have understood and agreed that no explanation or justification on any aspect of the Bidding Process or selection will be given.

3.3.3 Any information contained in the Proposal shall not in any way be construed as binding on the Authority, its agents, successors or assigns, but shall be binding against the Bidder if the Project is subsequently awarded to it.

3.3.4 The Proposals of the Bidders which are found to be in conformance with the Qualification Criteria as specified at Clause 2.1.1 shall be declared as qualified bidders (“**Qualified Bidders**”) and shall be considered for opening of the Financial Proposal. Proposals of a single business entity or consortium who do not meet these criteria shall be rejected.

3.3.5 The Financial Proposals of only the Qualified Bidders shall be considered for further evaluation.

3.4 Evaluation of Financial Proposal

3.4.1 The Financial Proposals of only the Qualified Bidders would be opened in the order specified in the table below in the in the presence of the Bidders(s) representatives who choose to attend on the date and time as may be intimated to the Qualified Bidders. The Financial Proposal shall consist of Annual Fee per annum payable by the Successful Bidder to the Authority for undertaking the Project.

- 3.4.2 The Authority will determine whether the Financial Proposals are complete, unqualified and unconditional. The cost indicated in the Financial Proposal shall be deemed as final and reflecting the total cost of services. The Highest Annual Fee above the Minimum Annual Fee as specified at Clause 1.2.7 shall be the sole bidding parameter for selection of the Bidder for award of the Project. The Bidder quoting the highest Annual Fee would be declared as the Successful Bidder for a particular Tourism Property

To be considered for more than one tourism property, a Bidder must demonstrate to have Financial Capacity as set out in Clause 2.1.1 (c) for the tourism property for which it has submitted the Financial Proposal. At the outset, the Financial Proposal of all Technically Qualified Bidders shall be opened for tourism property No. 1. The Bidder quoting the highest Annual fee amount would be the Successful Bidder for tourism property No.1. Thereafter the Financial Proposal of all Technically Qualified Bidders for the tourism property No.2 could be opened. However, if the Successful Bidder of the tourism property No 1 has also submitted its Financial Proposal for tourism property No.2, then its Residual Financial Capacity would be assessed and if his Residual Financial Capacity is adequate for tourism property No. 2 then its Financial Proposal for the tourism property No. 2, would be considered for opening. In case the Financial Capacity of the Successful Bidder is exhausted and the Residual Financial Capacity is not adequate for tourism property 2, then the Financial Proposal of such Successful Bidder shall not be opened for tourism property No. 2. The Successful Bidder for tourism property No. 2 would be the Bidder quoting the highest Annual Fee among the remaining Technically Qualified Bidders. The evaluation of the Financial Proposals of other tourism properties would be continued in the aforesaid manner.

For avoidance of doubt, no Bidder shall be eligible to get more than 4 (four) Tourism Properties under this RFP. In case the Bidder is currently operating and managing any one tourism property belonging to JTDC, such Bidder shall be eligible to be awarded with a maximum of 3 (three) tourism property only. In case the Bidder is currently operating and managing any two tourism properties belonging to JTDC, such Bidder shall be eligible to be awarded with a maximum of 2 (two) tourism property only. In case the Bidder is currently operating and managing any three tourism property belonging to JTDC, such Bidder shall be eligible to be awarded with a maximum of 1 (one) tourism property only. In case the Bidder is currently operating & managing 4 (four) tourism properties belonging to JTDC, such Bidder is not eligible to participate in this Bidding Process.

Note:Residual Financial Capacity of the Bidder shall be the Financial Capacity calculated by deducting the entire Financial Capacity required for the tourism property(ies) for which he is the Successful Bidder from his Financial Capacity. The calculation of Residual Financial Capacity shall be carried out for each of the tourism property for which he is considered as a Successful Bidder.

Following illustration is provided for the purpose of clarity;

Suppose, Bidder A, B, C and D are the Technically Qualified Bidders who have submitted Financial Proposals as given below with respect to tourism properties 1 to 5:

In the above scenario,

Step 1, the Financial Proposals received for tourism property No 1 from all the Bidders i.e. A, B and C shall be opened. If “B” offers the Highest Annual Fee in accordance with this RFP, then “B” shall be declared as the Successful Bidder for tourism property No. 1.

Step 2, the Financial Proposals received for Tourism Property No. 2 shall be opened. In the above example, before opening the Financial Proposal of B for tourism property No. 2, the

Financial Capacity of B for Tourism Property No. 2 would be assessed and if his Financial Capacity is not exhausted and the remaining Financial Capacity is adequate for tourism property No. 2, then his Financial Proposal for the tourism property No. 2, would be considered for opening. Suppose, "C" offers the Highest Annual Fee payable to the Authority for Tourism Property No 2 then C shall be declared as the Successful Bidder for Tourism Property No. 2.

Step 3, the Financial Proposals received for Tourism Property No. 3 shall be opened. At this stage, before opening the Financial Proposal of B and C for tourism property No. 3, the Financial Capacity of B & C for Tourism Property No. 3 would be assessed and if their Financial Capacity is not exhausted and the remaining Financial Capacity is adequate for tourism property No. 3, then the Financial Proposal of both B & C for the tourism property No. 3, would be considered for opening. If "B" offers the Highest Annual Fee, then B shall be declared as the Successful Bidder for Tourism Property No. 3.

Step 4, the Financial Proposals received for Tourism Property No. 4 shall be opened. At this stage, before opening the Financial Proposal of B and C for tourism property No. 3, the Financial Capacity of B & C for Tourism Property No. 4 would be assessed and if their Financial Capacity is not exhausted and the remaining Financial Capacity is adequate for tourism property No. 4, then the Financial Proposal of both B & C for the tourism property No. 3, would be considered for opening. If "B" offers the Highest Annual Fee, then B shall be declared as the Successful Bidder for Tourism Property No. 4.

Step 5, the Financial Proposals received for Tourism Property No. 5 shall be opened. At this stage, before opening the Financial Proposal of B and C for tourism property No. 3, the Financial Capacity of B & C for Tourism Property No. 5 would be assessed and if their Financial Capacity is not exhausted and the remaining Financial Capacity is adequate for tourism property No. 5, then the Financial Proposal of both B & C for the tourism property No. 3, would be considered for opening. If "B" offers the Highest Annual Fee, then B shall be declared as the Successful Bidder for Tourism Property No. 5.

Step 6, the Financial Proposals received for Tourism Property No. 6 shall be opened. At this stage, since "B" is already been declared as the Successful Bidder for tourism Property No.1 and 3, 4 and 5, the Financial Proposal of B for Tourism Property No. 6 shall not be opened. Before opening the Financial Proposal of C and D for tourism property no. 6, the Financial Capacity of C and D for Tourism Property No. 4 would be assessed and if the Financial Capacity of C and D is not exhausted and the remaining Financial Capacity C and D is adequate for tourism property No. 6, then the Financial Proposal of C and D for the tourism property No. 6, would be considered for opening. If "C" offers the Highest Annual Fee, then C shall be declared as the Successful Bidder for Tourism Property No. 6.

Step 7, the Financial Proposals received for Tourism Property No. 7 shall be opened. At this stage, since C and is already been declared as the Successful Bidder for tourism Property No.2 and 6 and C is also currently operating and managing 2(two) Tourism Property belong to the Authority , the Financial Proposal of C for Tourism Property No. 7 shall not be opened. The Financial Proposal of D for the tourism property No.7, would be considered for opening and shall be declared as the Successful Bidder for Tourism Property No 7.

Step 8, the Financial Proposals received for Tourism Property No. 8 shall be opened. At this stage, if D is already operating and managing 3 (three) Tourism Property belonging to JTDC, and has been declared as successful Bidder for Tourism Property No.7, then the Financial Proposal of D for the Tourism Property No.8 will not be opened, since D is already been awarded Tourism Property No.7.

The procedure applicable for selection of Successful Bidder for tourism properties from 1 to 6 shall apply mutatis mutandis for the rest of the Tourism Properties No.9 to 17.

- 3.4.3 In the event that two or more Bidders quote the same amount of Financial Proposal (the “**Tie Bidders**”), the Authority shall identify the Successful Bidder by draw of lots, which shall be conducted, with prior notice, in the presence of the Tie Bidders who choose to attend.
- 3.4.4 In the event, no Proposals are received for a particular Tourism Property, the Authority shall have the discretion to annul the process for that particular Tourism Property and invite fresh Proposals for that particular Tourism Property.

3.5 Letter of Acceptance (LoA) and Execution of PDMA

- 3.5.1 After selection, a Letter of Award (the “LOA”) shall be issued, in duplicate, by the Authority to the Successful Bidder and the Successful Bidder¹ shall, within 7 (seven) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. In the event the duplicate copy of the LOA duly signed by the Successful Bidder is not received by the stipulated date, the Authority may, unless it consents to extension of time for submission thereof, appropriate the Bid Security of such Bidder as mutually agreed genuine loss and damage suffered by the Authority on account of failure of the Successful Bidder to acknowledge the LOA.
- 3.5.2 After acknowledgement of the LOA as aforesaid by the Successful Bidder, it shall execute the PDMA within the period of 45 (forty five) days. The Successful Bidder shall not be entitled to seek any deviation in the PDMA.

3.6 Performance Security

- 3.6.1 The Successful Bidder/Developer shall within the date specified in the LOA, pay an amount equal to the Annual Fee offered by the Successful Bidder to the Authority towards performance security (the “**Performance Security**”) by way of an irrevocable Bank Guarantee issued by a Nationalised Bank or a Scheduled Bank in India in favour of Jharkhand Tourism Development Corporation Limited, payable at Ranchi, Jharkhand.
- 3.6.2 Failure of the Successful Bidder to furnish the Performance Security as provided in Clause 3.6.1 or enter into a PDMA with the Authority as provided in Clause 3.5.2 would constitute sufficient grounds for the annulment of LoA. In such event, the Authority reserves the right to

- a. forfeit the Bid Security amount of the Successful Bidder, and
- b. either invite the Bidder with the next best offer for negotiations, or
- c. take any such measure as may be deemed fit in the sole discretion of the Authority, including annulment of the Bidding Process.

3.6.3 The Authority will promptly notify other Bidders that their Proposals have been unsuccessful and their Bid Security will be returned as promptly as possible as and in any case not later than 60 (sixty) days from the date of announcement of the Successful Bidder.

3.7 Upfront Premium

The Successful Bidder with respect to each Tourism property shall within the date specified in the LOA, pay to the Authority an amount equal to the Annual Fee offered by the Successful Bidder by way of Upfront Premium² in the form of a Demand Draft from a Nationalised Bank or a Scheduled Bank³ drawn in favour of “Jharkhand Tourism Development Corporation Limited”, payable at Ranchi, Jharkhand. The Upfront Premium paid by the Successful Bidder shall be non-refundable in nature.

3.8 Success Fee

The Successful Bidder shall within the date specified in the LOA, pay an amount to the Authority an amount specified in the table below by way of Success Fee⁴ in the form of a Demand Draft from a Nationalised Bank or a Scheduled Bank⁵ drawn in favour of “Jharkhand Tourism Development Corporation Limited”, payable at Ranchi, Jharkhand. The Success Fee paid by the Successful Bidder shall be non-refundable in nature.

3.9 Project Development Expenses

The Successful Bidder shall with respect to each Tourism Property within the date specified in the LOA, pay to the Authority an amount specified in the LOA towards Project Development Expenses viz., professional fee paid to the consultant, advertisement cost, cost of conducting the pre-bid meeting, if any etc in the form of a Demand Draft from a Nationalised Bank or a Scheduled Bank⁶ drawn in favour of “Jharkhand Tourism Development Corporation Limited”, payable at Ranchi, Jharkhand. The Project Development Expenses made by the Successful Bidder shall be non-refundable in nature.

3.10 Contacts during Proposal Evaluation

Proposals shall be deemed to be under consideration immediately after they are opened and until such time the Authority makes official intimation of award/ rejection to the Bidders. While the Proposals are under consideration, Bidders and/ or their representatives or other interested parties shall not make attempts to establish unsolicited and unauthorised contact by any means, the Authority and/ or their employees/ representatives on matters related to the Proposals under consideration after opening of the Proposals and prior to notification of the Award. If any attempt by the Bidder causing extraneous pressure on the Authority shall be sufficient reason to disqualify the Bidder.

4. FRAUD AND CORRUPT PRACTICES

- 4.1. The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process. Notwithstanding anything to the contrary contained herein, the Authority may reject a Proposal without being liable in any manner whatsoever to the Bidder if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process.
- 4.2. Without prejudice to the rights of the Authority under Clause 4.1 hereinabove, if a Bidder is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, such Bidder shall not be eligible to participate in any tender or RFP issued by the Authority during a period of 2 (two) years from the date such Bidder is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case may be.
- 4.3. For the purposes of this Clause 4, the following terms shall have the meaning hereinafter respectively assigned to them:
- (a) “corrupt practice” means (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the actions of any person connected with the Bidding Process (for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of the Authority who is or has been associated in any manner, directly or indirectly with the Bidding Process or the LOA or has dealt with matters concerning the PDMA or arising there from, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of the Authority, shall be deemed to constitute influencing the actions of a person connected with the Bidding Process); or (ii) save and except as permitted under sub clause (d) of Clause 2.2.1, engaging in any manner whatsoever, whether during the Bidding Process or after the issue of the LOA or after the execution of the PDMA, as the case may be, any person in respect of any matter relating to the Project or the LOA or the PDMA, who at any time has been or is a legal, financial or technical adviser of the Authority in relation to any matter concerning the Project;
 - (b) “fraudulent practice” means a misrepresentation or omission of facts or suppression of facts or disclosure of incomplete facts, in order to influence the Bidding Process;
 - (c) “coercive practice” means impairing or harming or threatening to impair or harm, directly or indirectly, any person or property to influence any person’s participation or action in the Bidding Process;
 - (d) “undesirable practice” means (i) establishing contact with any person connected with or employed or engaged by the Authority with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Bidding Process; or (ii) having a Conflict of Interest; and

- (e) “restrictive practice” means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the Bidding Process.

5. MISCELLANEOUS

- 5.1 The Bidding Process shall be governed by, and construed in accordance with, the laws of India and the Courts at Jharkhand shall have exclusive jurisdiction over all disputes arising under, pursuant to and/ or in connection with the Bidding Process.
- 5.2 The Authority, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to;
- (a) suspend and/ or cancel the Bidding Process and/ or amend and/ or supplement the Bidding Process or modify the dates or other terms and conditions relating thereto;
 - (b) consult with any Bidder in order to receive clarification or further information;
 - (c) pre-qualify or not to pre-qualify any Bidder and/ or to consult with any Bidder in order to receive clarification or further information;
 - (d) retain any information and/ or evidence submitted to the Authority by, on behalf of, and/ or in relation to any Bidder; and/ or
 - (e) independently verify, disqualify, reject and/ or accept any and all submissions or other information and/ or evidence submitted by or on behalf of any Bidder.
- 5.3 It shall be deemed that by submitting the Proposal, the Bidder agrees and releases the Authority, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/ or performance of any obligations hereunder and the Bidding Documents, pursuant hereto, and/ or in connection with the Bidding Process, to the fullest extent permitted by applicable law, and waives any and all rights and/ or claims it may have in this respect, whether actual or contingent, whether present or in future.

- B. The Parties are interested in jointly bidding for the Project as members of a Consortium and in accordance with the terms and conditions of the RFP document and other bid documents in respect of the Project, and
- C. It is a necessary condition under the RFP document that the members of the Consortium shall enter into a Joint Bidding Agreement and furnish a copy thereof with the Proposal.
