SELECTION OF BIDDERS FOR SUPPLY OF CHANA DAL UNDER (PDS) PUBLIC DISTRIBUTION SYSTEM

2. INTRODUCTION

The Directorate of Food & Consumer Affairs, Govt. of Jharkhand (DF&CA) located at JSFC BHAWAN, KADRU, RANCHI, JHARKHAND, 834002 has entrusted the GeM Portal for conducting reverse e-auction for procurement of Chana Dal under PDS from registered bidders.

DF&CA, intends to invite tenders for purchase of approx. 2,04,000 Quintal Chana Dal in (July 2025 to September 2025) for the Government of Jharkhand's PDS (Mukhyamantri Dal Vitran Yojana). Applications are invited from bidders who are interested in participating in the reverse e-auctions. The registration procedure and application formats can be obtained from the website https://gem.gov.in/ or by downloading and submitting the registration form.

Earnest Money Deposit at the time of deposit in the shape of Bank Guarantee/Demand Draft (valid till 3 months) in favour of Director, Directorate of Food & Consumer Affairs, Government of Jharkhand.

3. SCOPE OF WORK

- 3.1. The DF&CA being the appointed agency for procurement of Chana Dal, under this scheme will select a supplier for the purchase of Chana Dal using reverse e-auction platform.
- 3.2. After this, the execution of agreement with selected Bidder, monitoring of procurement and distribution of Chana Dal will be done by DF&CA, Ranchi.
- 3.3. District Supply Officer shall issue the purchase order/ Indent as per requirement of that particular district directly to the successful bidder within a month and further for each month till the agreement period / termination of the agreement, whichever is earlier.

- 3.4 Jharkhand State Food and Civic Supplies Corporation Limited. Ranchi will execute the work related to the receipt, storage and dispatch through Door Step Delivery of Chana Dal provided by the bidder.
- 3.5. The monthly requirement of Chana Dal under PDS is approximately 68000 Quintal (ANNEXURE-2), which has to be supplied to the designated godowns of JSF&CSCL. The list of godowns/points is at ANNEXURE-8.
- 3.6. Reverse e-Auction will be held for procurement for Chana Dal, and the payment for the supply of Chana Dal will be released by the office of DF&CA on submission of bills as per prescribed procedure within Ten (10) working days.
- 3.7. For any changes or updates please check https://gem.gov.in/ and department website https://www.jharkhand.gov.in/food regularly.

4. INVITATION FOR BIDS

DF&CA, invites bids from interested bidders for the supply of 01 (one) kg Chana Dal packets in 50 (fifty) kg secondary package to such designated godowns situated in different blocks/districts within the territorial jurisdiction of Jharkhand as may be notified / communicated by DF&CA / DSO.

5. TERMS & CONDITIONS FOR SUPPLY OF CHANA DAL.

5.1. ELIGIBILITY CRITERIA FOR BIDDERS

Proprietor/ Partnership firm / Registered Company / Co-operative Society / Processor/ Supplier/ Producer/ Miller are entitled to participate in the electronic platform of the exchange. If Bidder is not a Manufacturing Firm/Miller, they should have:-

- i. They should have proper authorization from the Miller.
- ii. They should have legal agreement with the Miller.

The Miller should have valid pulses/ foodgrains factory licence, import licence (if applicable), GST registration issued by concerned authority. The applicant should also comply with the stock limit license as regulated by the respective state government from where the applicant belongs to.

Miller need to submit Manufacturing valid documents.

- a. The required annual turnover of the bidder, shall not be less than Rs. 50 crores (Rupees Fifty Crores) in every year, as reflected in the audited balance sheet, during the previous any three continuous financial years (i.e. F Y 2021-22, 2022-23, 2023-24 and 2024-25).
- b. The bidder will have to produce an audited copy of balance sheet and profit & loss accounts duly certified by a Chartered Accountant for the three (3) consecutive financial years (i.e. F Y 2021-22, 2022-23, 2023-24 and 2024-25).
- c. Income Tax Return of the three (3) continuous financial years (i.e. F Y 2021-22, 2022-23, 2023-24 and 2024-25) is required to be submitted by the bidder.
- d. A self-attested copy of GST registration certificate should be submitted by the Bidder.
- e. A notarized self-declaration on a non-judicial stamp of Rs.500/- stating that the bidder has extensive experience in this field and a good reputation in the market, and is not barred or blacklisted by any State or Central Government department or office, or offices of any Board, or any other local authority, for any period of time.
- f. According to the Food Safety and Standards Act, the bidder or its manufacturer must have an updated FSSAI licence/certificate and should submit an attached copy of the updated licence/certificate.
- g. ISO certificate for food safety and environment management should be submitted by the bidder.
- h. The participant has to produce the self certified and legible copies as the case may be as follows.
 - i. If the participant is a partnership firm then copy of partnership deed.
 - If it is co-operative society then it's copy of constitution and Registration number.
 - If it is registered company then it's copy of memorandum and Article of association along with incorporation certificate.

- iv. If Bidder is registered as micro, small and medium scale industries in Jharkhand, then a certified copy of registration certificate.
- v. Factory License wherever required.
- Millers having production unit in any State shall have sufficient milling capacity i.e.
 230 M.T/Day or above and also need to provide FSSAI/Factory Licence.
- j. The bidder must have minimum experience of (03) three years in the similar field which is supply of food-grain / pulses. In support of experience criteria bidder shall furnish and upload self-attested copies of work order/contract/agreement issued by the state or central government. Minimum experience of 10000 MT supply of Chana Dal in any State or Central Government organization.

Note: In the case of Jharkhand MSME, relaxation will be provided in accordance with the extant Jharkhand Procurement Policy.

5.2. PRICE:

- 5.2.1. Bidder will have to fill-up the rates in unit in Metric method i.e. in Quintal only.
- 5.2.2. The rates offered include all government duties, expenses such as transportation, transit losses, insurance, packing articles (gunny bags, etc.), and packing charges, among other things, plus applicable GST.
- 5.2.3. Bidder will have to quote the rates for the Chana Dal as per specification mentioned in ANNEXURE-4 & ANNEXURE-5.
- 5.2.4. The prescribed packing material and packing weight, etc. As per ANNEXURE-3.

5.3. PURCHASE QUANTITY:

The DF&CA, will purchase of approx. 2,04,000 Quintal Chana Dal in 2nd quarter (July 2025 to September 2025), (68000 Quintal Chana Dal per month) under PDS Mukhyamantri Dal Vitran Yojana.

5.4. VALIDITY/ LEGALITY:

The bids of all bidders, who have participated in the bidding, will remain valid for the minimum period of three (3) months from the date of closing of bidding.



EARNEST MONEY DEPOSIT (EMD)

- 5.5.1 The registered bidders need to submit 2% (Two percent) of the quoted bid value as Earnest Money Deposit (EMD) of Rs. 3.30,50,000/- (Rupees Three Crore Thirty Lakh Fifty Thousand Only) as per bid details in the form of Bank Guarantee / Demand Draft issued from any nationalized bank / scheduled bank in the name of " Director, Directorate of Food and Consumer Affairs, Jharkhand Ranchi "in the office of Directorate of Food and Consumer Affairs. Jharkhand, Ranchi, 3rd Floor, JSFC Bhawan, Kadru, Ranchi - 834002 only after but within 03 working days from last date of submission of bid documents"
- 5.5.2. The successful bidder upon receipt of communication regarding acceptance of bid by the Directorate of Food and Consumer Affairs shall arrange to submit an amount equivalent to 5% (five per cent) of the value of the order as Security Deposit (ePBG) within 10 days from the date of declaration of e-Bid as Bank Guarantee (valid for one year) in favor of "Director, Directorate. of Food and Consumer Affairs, Jharkhand Ranchi ".
- 5.5.3. EMD of the lowest bidder (L1) will be blocked by the DF&CA till the security deposit. Once the bidder submits the security deposit the EMD will be released.
- 5.5.4. EMD of the unsuccessful bidder(s) including those whose bid(s) are not accepted due to non-fulfillment/not meeting the conditions attached to the bid(s), shall be returned by of DF&CA on the withdrawal request made by the bidder after the agreement with (L1) bidder.
- 5.5.5. If the successful bidder fails to supply the entire ordered quantity as per the prescribed quality at designated centers, Security Deposit shall stand forfeited and the supplier will be blacklisted.
- 5.5.6. In case, if the bidder fails to complete the delivery of goods in time (including the late delivery period) and as per the terms and conditions of the tender document, the DF&CA reserves the right,
 - To cancel the order for the quantity not supplied by the bidder and

b. Bidders will be blacklisted.

c. Security Deposit of the bidder will be forfeited as per terms & conditions.

5.5.7 Security Deposit furnished by the qualified bioders will be returned on request upon completion of the contract period or the extended period, if any, subject to satisfactory performance or execution of the contract as per the Terms and Conditions of the contract.

5.6. RIGHTS OF DIRECTORATE OF FOOD & CONSUMER AFFAIRS:-

The Directorate of Food & Consumer Affairs, Govt. of Jharkhand reserves the right. without giving any reason, to accept or to reject all or any bid including the lowest bid.

5.7. TRANSIT RISK:-

The bidder is bound to send the goods of prescribed specification at the prescribed Centers/ JSF&CSCL Godowns at his own risk and cost. The transportation cost and the transit risk shall be borne by the bidder.

5.8. AGREEMENT AND WORK ORDERS FOR SUPPLY OF CHANA DAL:-

- 5.8.1. The lowest bidder will be declared as the successful bidder by the DF&CA and has to sign the agreement within 7 (Seven) working days.
- 5.8.2. The execution of agreement with selected Bidder will be done by the DF&CA, Ranchi.
- 5.8.3. The supplier is required to enter into an agreement on Rs 1000/- e-stamp paper with DF&CA to fulfill the contractual obligations as specified by the DF&CA. The draft format of agreement is furnished vide ANNEXURE-6. Only winning bidders are required to enter in agreement with DF&CA.
- 5.8.4. Agreement not accompanied by document/proof or with any alterations to clauses of the agreement will not be accepted and will be deemed as nonsubmission of agreement and violation of the terms and conditions.
- 5.8.5. Violation of any of the Clause/Clauses of the Agreement shall be deemed as violation of Terms and Conditions of this contract.
- 5.8.6. Non execution of agreement within seven days will amount to forfeiture of EMD (Earnest Money Deposit) deposited along with blacklisting from participating in the subsequent e-auctions for a period of three years.

- 5.8.7. District Supply Officer shall issue the purchase order Indent as per requirement of that particular district directly to the successful pidder within a month and further for each month till the agreement period / termination of the agreement whichever is earlier.
- 5.8.8. DSO does not guarantee the minimum quantity, which will be ordered. DSO reserves the right to order for only such quantity as may be necessary or required by the respective district and the qualified bidder is bound to supply the ordered quantity at the designated JSF&CSCL godowns spread across the concerned district.

5.9. DELIVERY OF CHANA DAL

- 5.9.1. The successful bidders should take adequate precautions to prevent damage or deterioration to Chana Dal during storage/ transportation.
- 5.9.2. The successful suppliers should deliver at his cost the Chana Dal to the designated JSF&CSCL Godowns/storage place as per the purchase order / indent issued by DSO.
- 5.9.3. The Bidder has to deliver the goods of specified quality in prescribed packing with a net weight of 1kg poly packing and 50 kg secondary packing.
- 5.9.4. To ensure the timely supply of Chana Dal, short listed supplier will be given the godown wise monthly Chana Dal requirement along with the purchase order and the calculation of penalty will be done from the date of issue of purchase order/indent. Also, the supply of Chana Dal shall be completed as per the below schedule:

- 5.5. In case of non-supply of the fixed quantity within the stipulated time under the supply order for the quantity not supplied within the stipulated time a penalty will be imposed in the second party as per mentioned penalty clause 5.15.6.
- 5.9.6. In case the quantity as per prescribed quality under the supply order is not supplied, It must be get replaced within 07 (seven) days with the prescribed quality. If not done so a penalty will be imposed in the second party as as per mentioned penalty clause 5.15.7.
- 5.9.7. Quantities supplied in excess of the quantity specified in the purchase order will not be paid for. Supply of required quantity should be as indented by the DF&CA. DF&CA at his sole discretion may place Purchase orders/indents by Online/ FAX/ LETTER/ E-MAIL, pending execution of agreement. The successful qualified bidder is bound to honor such indents and shall arrange to supply requisite quantity of Chana Dal to the designated locations.
- 5.9.8. The stock of goods will be unloaded from the vehicle by the supplier and stacking will be arranged in such a manner that, the samples can be obtained from each and every bag easily.
- 5.9.9. Consignment will be unloaded at the designated JSF&CSCL godowns during working hours only i.e. between 10 AM and 5 PM. On arrival of the consignment the Assistant Godown Manager will verify the documents. On confirming the authenticity of the consignment and after being satisfied with the quality of Chana dal, direct the representative of the bidder to arrange for recording the gross weight of the consignment on an weighbridge before unloading.
- 5.9.10. After unloading, the tare weight of the truck is recorded on the same weighbridge. The copies of the Weigh Bridge receipts at the unloading point along with other documents i.e. invoice/ delivery challan, and weighbridge receipts at the unloading point shall be handed over to the Assistant Godown Manager of JSF&CSC LTD.
- 5.9.11. If the bidder fails to supply in the stipulated time period for any administrative reason, The Director (Directorate of Food & Consumer

- Affairs, Govt, of Jharkhand) reserves the right to grant any extension with or without penalty
- Default in supplies either wholly or partly on account of quality or quantity 5.9.12 will result in forfeiture of security deposit and other penalty measures.
- 5.9.13. At any stage of supplies under the scheme, if it is noticed that the supplies are not in conformity with the specifications prescribed, such materials are liable to be rejected and qualified bidder will be called upon to replace the same. In the event of qualified bidder failing to replace the rejected stocks within seven (07) days from the date of intimation of rejection of stocks, the security Deposit and EMD (Earnest Money Deposit) furnished by the qualified bidder shall be forfeited and action under the existing laws will be initiated to recover such losses.

5.10. SPECIAL CHECKING

- 5.10.1. The appointed representative of DF&CA may take the samples at the milling unit/ factory site / Godowns / Stocking yard/ FPS Shop's for quality checking of the goods as per specifications prescribed by DF&CA and carry out due diligence of quality inspection.
- 5.10.2. Once the samples of the goods are found as per the quality parameters, the goods will be accepted. If the goods are not found as per the prescribed quality parameters, the goods will be rejected and the rejection charge will be recovered at Rs.1,00,000/- (One lakh) per Batch.
- 5.10.3. In case of stock getting rejected in cross verification, the bidder shall replace the stock within 7 working days from the date of the quality analysis report of DF&CA. In case of failure, a penalty of 5% of the purchase value shall be recovered.

5.11. PACKING

5.11.1. The bidder shall supply the Chana Dal packed in 1kg. net weight in the new bags in packing mentioned in the tender document with marking as prescribed in ANNEXURE-3 of the tender document. Mummin

- 5.11.2. Chana Dal is to be delivered by the bidder in 1kg weight poly packing 50 kg secondary packing. The quality of the backing will be as per BIS-IS 14887:2006.
- 5.11.3. Each Packet should have such QR Code as decided by the DF&CA, Batch no and FSSAI licence number.



- 5.11.4. Each bag should be machine stitched with white thread. There should not be any other marking other than the bidder's logo, vegetarian logo, and other detail as mentioned in the tender documents.
- 5.11.5. As per the format given by DF&CA, the bidder has to print barcode on each 1 kg bag of Chana dal and 50 kg secondary package.
- 5.11.6. The bidder must have printed Batch no. on 1 kg pouch packing. Batch no. should be unique.
- 5.11.7. The bidder will provide 01 (one) kg Chana dal packets in 50 (fifty) kg package in the godown, which will be mandatory to have such QR Code that has been approved by the DF&CA, and that can be accessed and scanned through the department's portal.
- 5.11.8. Supply of Chana Dal in such bags or printing which does not contain the prescribed mandatory details will not be accepted.

5.12. QUALITY

Quality specifications prescribed for Chana Dal (ANNEXURE-4 & ANNEXURE-5) are to be followed by the bidder strictly.

5.13. SAMPLING

5.13.1. The appointed representative of the JSF&CSCL/DSO may take block wise / Batch wise sample or samples from PDS shops on random basis for quality checking of the goods as per specifications prescribed by DF&CA and carry out due diligence of quality inspection.

- 5.13.2. It will be mandatory for the bidder of Chana Dal to be registered with FSSAI and the license number of FSSAI should be recorded on the packet of Chana Dal supplied. The samples will be sent to NABL accredited laboratory for testing, following the procedure as prescribed, to ensure the quality of the Chana dal supplied by the bidder.
- 5.13.3. NABL Accredited Laboratory Test should be done on the basis of sample taken from block Godowns / PDS.
- 5.13.4. All the expenses for test reports of samples conducted by NABL Accredited Lab shall be borne by the Bidder.
- 5.13.5. On arrival of goods the AGM,JSF&CSCL will verify the documents and unload the truck after confirming the authenticity of the consignment, will draw a sample for cross-verification.
- 5.13.6. The bags should be stacked in such a manner that, each bag gets representation for inclusion in the representative sample and the sample can be drawn easily from the upper, middle, and lower parts of the stack at the time of unloading, the representative of DSO/JSF&CSCL may take the sample and DSO will send it for testing in NABL accredited laboratory.

5.13.7. (Parakhi) draw Sampling

Samples from the upper level, Middle Level, and bottom level of the stack will be drawn. For this, the IS 14818:2000 procedure will be followed. At least 3 to 4 packets of 1 Kg Chana Dal. the weight of representative samples will be collected as per requirement.

- 5.13.8. Bidders should give an assurance that if any complaint is received from end users regarding quality, the same will have to be resolved as per the decision of DF&CA.
- 5.13.9. The NABL accredited lab analysis report is considered final.
- 5.13.10. DF&CA has the right to do resampling of commodity and can take action based on reports/ test results.
- 5.13.11. If the DF&CA suo moto or on receipt of the complaint about the poor quality, the DF&CA reserves right to do resampling of the commodity Page 16

DF&CA at any point of time has the absolute authority to draw a sample, either suo moto or on the complaint received in this regard and the sample, either can be tested on its own, without informing to the authorized person of the bidder. However if the result of such a sample report turned out vastly different than the earlier reports, the DF&CA reserves the right to blacklist the bidder, all persons connected with it, authorized representatives, and persons concerned with such authorized representative after giving them an opportunity of being heard."

5.13.12. If the result of the NABL Accredited Lab differs, the bidder must replace the stock within seven (7) working days of being notified, or within the days determined by the DF&CA. DF&CA office has the right to levy a penalty. DF&CA Office, will impose a 5%penalty on the value of replaced goods. However, DF&CA has the sole authority to increase the penalty rate. DF&CA, has the authority to levy penalties on both replaced and distributed stock from the respective lot, as well as stock from Godowns.

5.14. PAYMENTS

- 5.14.1. In the light of resolution no.- 2495 dated:22-08-2023 of the Department of Food Public Distribution and Consumer Affairs, Jharkhand, Ranchi, the process of purchasing of Chana Dal through tender and payment against it will be done by the Director, Directorate of Food and Consumer Affairs, Jharkhand.
- 5.14.2. The Amount for payment of bills for Chana Dal supplied on the basis of open tender shall be made available to the Director, Directorate of Food and Consumer Affairs, Jharkhand.
- 5.14.3. Payment will be made for every successful completion of supply/ order and after receiving satisfactory final test report from NABL accredited laboratory by DF&CA within Ten (10) working days from the receipt of the bills.



GENERAL CHARACTERISTICS.

The Red Gram split pulses (husked) shall -

- a. Be the processed splits of mature dried, whole grains of Cajuns Cajan, syn, cajanus indicus;
- Be sweet, clean, wholesome, uniform size, shape, colour and in sound merchantable conditions.
- c. Be free from living and dead insects, fungus infestation, deleterious substances, added colouring matter, moulds, obnoxious smell, discolouration.
- d. Be free from rodent hair and excreta.
- e. Be free from toxic or noxious seeds, viz. Crotolaria (Crotolaria spp.), Corn cockle (Agrostemma githago L.), Castor bean (Ricinus communis L.), Jimson weed (Dhatura spp.), Argemone mexicana, Khesari, and other seeds those are commonly recognize as harmful to health.
- Uric acid and Aflatoxin shall not exceed 100 mg and 15 micrograms per kilogram respectively.
- g. Have good cooking quality.
- In addition to above parameters, it shall also conform to FSSAI, Act, and Rules and Regulation.

NOTES: Foreign Matter means any extraneous matter other than food-grains comprising of Inorganic and organic matter.

- Inorganic consisting of metallic pieces, sand, gravel, dirt, pebbles stones, glass and metallic pieces, lumps of earth clay and mud and animal faith.
- Organic matter shall include husk, chalf, straw, weed seeds and other inedible grains. Paddy shall be considered as foreign matter in commodities other than Paddy.



- B. Other edible grains means any edible grains (including cilseeds) other than the one which is under consideration.
- C. Damaged or discoloured pulses are those pulses that are internally damaged or discoloured to such an extent that such damage or discolouration materially affects the quality of the pulses.
- D. Slightly touched pulses are those pulses that are superficially damaged or discoloured, such damage or discolouration not materially affecting the quality of the pulses.
- E. Green Grains are those pulses that are green in colour.
- F. Brokens include pieces below 3/4 and above 1/4 of the full size of the split pulse. Fragments include pieces below 1/4 of the full size splits of the same sample.
- G. Weevilled pulses are those pulses that are partially or wholly bored or eaten by weevil or other grain insects.
- H. Partially husked/splits and wholes (both husked and un-husked) include
 - 1. Pieces those are partially husked, and
 - 2. Wholes whether with husk or without husk.

Partially husked means kernnels or pieces of kernnels carrying husk on 1/16th (One sixteenth) or larger portion.

The copies of the Weigh Bridge receipts at the unloading point along with other documents i.e. invoice/ delivery challan, and weighbridge receipts at the unloading point shall be handed over to the Assistant Godown Manager of JSF&CSC LTD
- 1.9. If the bidder fails to supply in the stipulated time period for any administrative reason, The Director (Directorate of Food & Consumer Affairs, Govt. of Jharkhand) reserves the right to grant any extension with or without penalty.
- 1.10. Default in supplies either wholly or partly on account of quality or quantity will result in forfeiture of security deposit and other penalty measures.
- 1.11. If the supplier fails to supply less than 50% of the ordered quantity within the stipulated delivery (Max. extension upto 10 days) schedule, the proportionate security deposit of the bidder will be forfeited. DF&CA will also recover differential amount on quantity not supplied by the bidder and DF&CA purchases the same quantity from alternative sources.

6. Fraud & corrupt practices
