Annexure "A"

1. Objective:

The Jharkhand High Court has digitized the legal cases by scanning the files. The question is how can make the use of digitized files in order to deal with the ongoing pendency of cases. With lack of staff and increasing number of cases, multiple concerns arise while trying to fast track the process. About 250 cases are filed everyday in the High Court with an average size of 100 pages per case. This naturally takes a long time to read and understand. The purpose is to use historical data and previous decisions/orders/judgments to assist in decision-making?

2. Scope of Work:

Must have a computer system capable of reading millions of words/pages per second to process so much information flow in the form of appeals/cases filed on daily basis. An A.I. system should be capable of extraction of data from the scanned files that can read through a single case in a matter of seconds to help in preparation and decision-making for judges. Use of A.I. + B.I. + Dashboard + interactive chat bots with (i) voice recognition, and (ii) speech recognition, can significantly contribute in expediting the judicial process.

A system should be capable of reading through the scanned documents and retrieve information to assist judges can certainly do wonders in dealing with pendency by fast-tracking the overall judicial process.

- a. Platform should be capable of intelligent data management
- b. Data engine should be capable of
 - i. Language detection
 - ii. Translation
 - iii. Entity relation detection
 - iv. Classification
- c. Storage structure of unstructured data containing main database, indices, and knowledge base for legal application
- d. A.I. engine for analyzing structured and unstructured data and information that can support A.I. application services
- e. A.I. dashboard for viewing key cases by case type, pendency, allotment, and other required criteria
- f. Smart search option to support research and cluster linkage for case study and study history
- g. Chat bots application capable of
 - i. Understanding spoken language by human entity
 - ii. Understanding query and producing relevant/necessary answer to query from the case-file uploaded
- h. Security parameters for hack and tamper prevention
- i. Security Audit of the Developed application
- j. Training & User manual

k. Deployment at Jharkhand State Data Center on Cloud environment.

3. Solution Required

A platform should be supported by an A.I. data engine and A.I. (NLU – Natural Language Understanding) engine capable of understanding:

- 1. Complexity of legal matter
- 2. Contextual analysis of legal matter
- 3. Maintain centralized database for smart search and automated sorting of cases
- 4. Anticipate procedural deficit
- 5. Predict Applicability of law (IPC/CrPC)

4. Features

Allows judges to interact with the systems in natural verbal language to extract information from any given case for the purpose of understanding the case, information gathering from files, and research for investigation purposes. For the purpose of ease of usage, the system must have advanced voice & speech recognition to understand and process spoken language of the judges (with and without accent).

A judge can simply type or speak to ask questions such as:

- How many cases do we have in the roster today?
- What is the case type?
- What is the matter about/What are the case details?
- Give me key details of the case.
- Re-direct me to pages showcasing issues in the matter
- What is the case law?
- Which other cases have used same/similar case laws?
- ➤ What is the nature of crime?
- What is the venue of crime?
- How many/which accused parties are acquitted?
- What time did the incident occur?
- And more.

The system must also include a custom developed smart dashboard. Apart from these, the system must include B.I. features to help visualize data and activities of the court.

The platform must allow new applications to be built on top of the database to facilitate more features to meet future needs and/requirements as they arise.

5. Qualification Criteria

- a. The Firm should be a Business Entity shall mean a company registered in India under
- Under the Companies Act 1956
- -Companies registered under Companies Act 2013
- Partnership firms registered under Limited Liability Partnerships (registered under LLP Act, 2008)
- Partnership firms registered under Indian Partnership Act, 1932

- b. The Solution Software and BA/BI tools should be from same Vendors/Firms

- **d. Implementation Schedule** Firms has to submit the Implementation time plan.

6. General Terms & Condition

IPR & Source Code: The proposed application IPR and source code should be with Jharkhand Government.

Knowledge Transfer: Knowledge Transfer should be done to Department within the project period

7. Evaluation Criteria and Method of Evaluation: a. Screening of EOIs shall be carried out as per eligibility conditions mentioned in this document and based on verification of testimonials submitted.

Agencies who qualify as per the eligibility conditions will be provided a brief about the Solution. The agencies may be required to make a presentation as per the scheduled date, if required, to a selection committee show-casing their proposals.
