SAJHA invites proposal from qualified sculptor/plastic artist (Referred as "Artist") to design, produce and supervise the erection of Bhagwan Birsa Munda and Marang Gomke Jaipal Singh statue 5'6" to 6' at Birsa Munda Football Stadium and Marang Gomke Jaipal Singh Astroturf Hockey Stadium, Ranchi, Jharkhand, respectively ("The Project"). Sealed (Lac and Stamp) quotation of rates are invited from the intending reputed sculptors/plastic artist for design, produce and supervise the erection of Bhagwan Birsa Munda and Marang Gomke Jaipal Singh at Birsa Munda Football Stadium and Marang Gomke Jaipal Singh Astroturf Hockey Stadium, Ranchi, Jharkhand, respectively.

**B. SUBMISSION, RECEIPT AND OPENING OF PROPOSALS**

- I. The Financial proposal must be submitted in hard copy using Form FIN-1. The billing rate shall be inclusive of design, produce and supervise the erection of Bhagwan Birsa Munda and Marang Gomke Jaipal Singh statue at Birsa Munda Football Stadium and Marang Gomke Jaipal Singh Astroturf Hockey Stadium, Morhabadi, Ranchi, Jharkhand, respectively as per the technical specification detailed in the ToR including cost of supply, packaging, transportation, supervising the erection, personnel, all out-of pocket expenses, documentation overhead, all the taxes, etc, exclusive of foundation/platform work.
- II. The Financial proposal shall be placed in a sealed Envelope –2 clearly marked by red pen “FINANCIAL PROPOSAL” and with a warning “DO NOT OPEN WITH THE TECHNICAL PROPOSAL’
- III. Two envelopes shall be a placed into an outer envelope and sealed by Lac. The outer envelope shall bear the submission address, reference number and Title of the Project, Proposal Due Date.
- IV. Proposals must be delivered at the indicated addresses on or before the time and date stated in the Data Sheet or any new date extended by SAJHA

**C. EVALUATION, AWARD AND SIGNING OF AGREEMENT**

1. The proposals will be evaluated on Quality cum Cost Based services with a weight age of Technical (70%) and Financial (30%)



2. SAJHA reserves the right to reject any proposal which is non-responsive.
3. It is mandatory to submit all the information as asked in the technical bid.
4. Each invited applicant shall be required to submit a miniature model of statue in POP of size not less than 1' (One foot) high depicting the quality and concept of the sculpture along with its two photographs
5. The bidder who score more than or equal to 70 marks out of 100 in technical shall only be eligible for financial opening

6. The lowest evaluated Financial Proposal ( $F_m$ ) will be given the maximum financial score ( $S_f$ ) of 100 points ( $S_f = 100 \times F_m / F$ , in which  $S_f$  is the financial score,  $F_m$  is the lowest price and  $F$  the price of the proposal under consideration.). Proposals will be ranked according to their combined technical ( $S_t$ ) and financial ( $S_f$ ) scores using the weights ( $T =$  the weight given to the Technical Proposal;  $P =$  the weight given to the Financial Proposal;  $T + P = 1$ );
7. The Artist/Sculpture achieving the highest combined technical and financial score will be invited for negotiations ( $S = S_t \times T\% + S_f \times P\%$ ).
8. It shall be mandatory upon the applicants to make themselves available for the presentation and viva-voce before the committee.
9. Models of finally selected bidders shall be kept by the SAJHA. Other applicants may take back their models once the work is awarded to the finally selected bidder. Nothing shall be payable to the bidder for either providing the models or for attending the presentation.
10. Financial Proposals of only technically qualified bidders shall be opened publicly in the presence of the representatives.
11. Lowest Financial bid amongst all opened financial bids shall be identified and will be considered for award of work or part thereof at the discretion of SAJHA.
12. The event of acceptance of the Proposal of the Preferred Bidder with or without negotiations, SAJHA shall declare the Preferred Bidder as the Successful Bidder. SAJHA will notify the Successful Bidder through a Letter of Acceptance (LoA) that its Proposal has been accepted.
13. Notwithstanding anything contained in this tender, SAJHA reserves the right to accept or reject any Proposal, or to annul the bidding process or reject all Proposals, at any time without any liability or any obligation for such rejection or annulment.
14. The contract shall commence from the date of signing of the contract agreement.



#### **D. TERMS OF REFERENCE AND SCOPE OF SERVICES**

Specification of Statue:

1. The height of Bhagwan Birsa Munda (Life Size) statue should be 5'6" to 6'
2. The height of Marang Gomke Jaipal Singh Munda (Bust size) statue should be 5'6" to 6'
3. The statues should be made up of reinforced glass fibre with minimum four layer of casting.
4. Bhagwan Birsa Munda sculpture should possess revolutionary pose and Marang Gomke Jaipal Singh Munda sculpture should possess as Hockey Player with smiling face.
5. The statue should be aesthetically pleasing from all sides, visually interesting, approachable and appealing to all ages
6. The surface shall be polished and treated to with stand all weather conditions. The coating and layering shall be got approved from expert committee.
7. It is the responsibility of the bidder to erect the statue under his directions. SAJHA shall not provide any machineries, equipment's, scaffolding and labour for assisting the erecting process.
8. The finished statue should be transported safely by the bidder at his own risk and cost. The statue shall be got insured by the bidder at its own cost till satisfactorily erecting of Statue on site.
9. No advance payment shall be made in advance.
10. All payment shall be made after successful completion of the "Project"
11. Bidder should require to provide the GST number. If in case bidder fails to provide the same, GST applicable shall be deducted during the payment as per the existing rules and prevailing rates
12. Also, TDS shall be deducted during the payment as per the existing rules and prevailing rates
