

Response to the issues raised in the Pre Bid meeting held on 29th June 2018 for Tender for Transport & Handling Services 2018-20 by JSFC&CSCL

1. **Clause 17.3 "The average annual turnover of the Tenderer for the last three financial years namely 2015-16, 2016-17 and 2017-18 shall be –**

Rs 1.5 Crore in case the Tenderer is exclusively carrying on the business of transportation goods.

Or

In case transportation of goods is one of the businesses of the Tenderer, at least Rs 1.5 Crore of the turnover shall be due to transportation business."

To be read as

"The average annual turnover of the Tenderer for the last three financial years namely 2014-15, 2015-16 and 2016-17 shall be –

Rs 1.5 Crore in case the Tenderer is exclusively carrying on the business of transportation goods.

Or

In case transportation of goods is one of the businesses of the Tenderer, at least Rs 1.5 Crore of the turnover shall be due to transportation business."

2. **Clause 19.10 "Attested Copy of last 3 years Income Tax Return."**

To be read as

"Attested Copy of audited Income Tax Return for the FY 2014-15, 2015-16 and 2016-17 .

3. **Clause 19.9 "Detailed Audited account / P&L Account of last three years should be attached"**

To be read as

"Detailed Audited account / P&L Account for the FY 2014-15, 2015-16 and 2016-17 should be submitted.."

4. **As labour licence is issues by the competent authority only after the agreement is signed, hence it should be excluded from the technical bid and shall be submitted at the time of signing the contract.**

Labour licence can be excluded from technical bid and should be submitted by the party during the signing of the contract.

5. **Clause 19.7 "A description note of Fixed & Movable Asset issued by Sub-Divisional Officer, which at least should have value of Rupees Seventy Five lakhs."**

to be read as

Clause 19.7 any of the following document should be submitted

a. "A description note of Fixed & Movable Asset issued by Sub-Divisional Officer, which should have value of more than Rupees Seventy Five lakhs and should be issued post publication of the tender to be considered valid."

b. Bank Guarantee for a value of ₹ 75 Lakhs in favour of Jharkhand State Food and Civil Supplies Corporation Limited payable at "Ranchi"

6. **Clause 25.6.4 The Corporation shall fix the ceiling bid rate (Rupees per quintal per Kilometre) for each Lot and generally the basis for fixing such ceiling bid rate is average cost of transportation for respective Lots for the previous year which are approved tendered rates by the Corporation. The bid rates above ceiling bid rates will be rejected. For the rejected Lots re-auction will be conducted.**

Stands deleted and shall not form a part of the tender document.

7. **Clause 19.6 "Character Certificate / Residential Certificate issued within last six months by Deputy Commissioner or Official authorized by Deputy Commissioner**

stands amended as below :

The original copy of the Character Certificate issued by the Deputy Commissioner or the official authorized by the Deputy Commissioner or Sub Divisional Officer should be submitted, however, for those who have applied for the same should submit the acknowledgement receipt

- 8. Clause 1.10 & Clause 1.12 of the Annexure-2 stands deleted.**
- 9. Clause 19.8 "Insolvency Certificate / Financial Capability Certificate issued by Bank in last One year (which as per banking transaction should have turnover of Rs 1.5 Crore).**

To be read as

Solvency Certificate / Financial Capability Certificate issued by Bank in last One year (which as per banking transaction should have turnover of more than ₹ 1.5 Crore).
