The selected supplier shall be liable to supply the required amount of Common Rice at the designated godowns by 15 th of January 2023. This cycle will be followed without fail. In case of delayed delivery DSO would impose penalty of Rs.1000/Quintal for first 5 days beyond the stipulated time on undelivered quantity. In case of further delay from 6th to 10th day's penalty would be Rs. 4000/Quintal. Delivery after 10th day will not be accepted and would be penalized for remaining quantity at Double of L1 rate.
3.	9.1.1	Authorised dealer/distributor certificate issued by the manufacturer to the bidder for the particular brand/brands of tendered item.	This clause can be removed as by mistake this caluse remained in RFP.
