Major Points of Discussion:

- **Chancellor Portal:** Admission number to be given to students during admission that will automatically updated in Chancellor Portal. The admission number shall be mandatory for document verification and fee submission. The student details may be verified with the admission number. This procedure may start from the next academic session/ (Compliance: Sri. N.N. Mishra, NIC)
- **Baseline data:** The portal shall have detail information on teaching and non-teaching staffs. The portal shall go live by 15th Jan after two trials (Compliance by Kumar Chandan).
- **Pay Fixation Portal:** The flow chart for preparation of the portal to be prepared with the help of PMU. The flow chart for preparation of the portal to be prepared with the help of PMU.
- **Grant –in Aid to Vitt Rahit Colleges:** The flow chart for preparation of the portal to be prepared. (Compliance: Purushottam)
- **Development of Portal:** The flow chart for Guruji Credit Card Portal, Mukhyamantri Shiksha Protsahan Yojana and Eklavya Prashikshan Yojana Portal, CM Fellowship Portal to be prepared. The link of the portal to be given through Departmental website (Compliance: PMU)
- **Implementation on e Samarth:** All the State Universities shall adopt e Samarth for creating common digital platform. The PMU will coordinate between Universities and team of e Samarth for customization of the portal as per the need of the University. A PPT on e-Samarth will be presented in the meeting on 16-12-2022.
- **Status of Wi-Fi project:** A letter to be issued to NICS to apprise Department on detail information about the status of the project on Friday at 11:00 am through physical meeting. BSNL representatives will also be a part of the meeting.
 - It was directed to collect all the information about the physical and financial status of the project and identify the gaps. (Compliance: PMU)
 - BSNL was directed to prepare DPR of DSPMU, BBKMU, Jamshedpur Women's University, JUT, four Government polytechnics, Palamu Engineering College and remaining 50 constituent colleges.
 - The list of the left out Universities and colleges will be shared to BSNL and a letter to be issued to the Universities and Colleges regarding preparation of DPR on Wi-Fi by BSNL. (Compliance: Dr. Hemendra Kumar Bhagat).

- BSNL shall submit the DPR of all the remaining Universities and Colleges by 10th January.
 - It was directed to release the remaining payment of BSNL (Compliance: Sri Barwal)
 - **National Knowledge Networking Project:** The central government project NKN has been implemented in 5 State Universities but Kolhan University, Nilamber Pitamber University, Sido Kanhu Murmu University are not using the features of NKN. It was directed to issue letter to 03 Universities for use of NKN. (Compliance: Dr. Hemendra Kumar Bhagat)
 - **Student Resource Centre:** SRC shall be established in all the Universities and colleges by Common Service Centre that will offer G2 Services and Educational Services. A PPT shall be presented by CSC team on 16-12-2022 on the services to be offered by them. The SRC may offer the following services: -
 - Support the students in filling admission form through Chancellor Portal
 - Online classes through Swayam and MOOC
 - Support the Universities in digitization of credentials (all type of certificates and marksheets) of students to upload in NAD
 - Learning Management System
 - **Learning Management System:** It was directed that team headed by Sri. Sayyed Riyaz Ahmed, Dr. Hemendra Kumar Bhagat, PMU and Representative of CSC, Kumar Chandan shall conduct a meeting on 15-12-2022 at 12: 00 pm and prepare a descriptive plan on LMS.
 - **Website of JSHEC:** It was directed that a website of the Department shall be developed with two tab on JSHEC and JCST. The link of all the portals shall be linked with the Departmental's portal. The present website of JSHEC will include the project management of all the State Scheme under Scheme Management Scheme. directed (Compliance: Kumar Chandan)
 - **NAD/ABC:** The Universities were directed to upload the documents for past 3 years within March 2023 and further 7 years within September 2023 in NAD portal. (Compliance: PMU)
