**1. DBA-cum-DATABASE DESIGNER (No of Post-01)**

- Monthly Pay** : Negotiable up to a maximum limit of Rs. 50,000/- p.m.
- Post Qualification** : BE/B.Tech (Computer Science / IT / ECE / EEE) / M.C.A. or equivalent.
- Age** : Maximum 45 years as on last date of application submission.
- Experience** : Minimum (05) five years of total post qualification



experience in IT sector including at least 3 year's experience of working as DBA.

- Technical Skills** : Candidates must have a working knowledge of PostgreSQL database. In addition to PostgreSQL, knowledge of databases like Oracle/MySQL will be an added advantage. Candidates should also have general understanding of storage technologies, memory management, NAS/SAN, Networking.
- Job Description** : Design the database as per application needs; organize & implement data structure, handle the security measures, backup and recovery of database, disk load balancing, Monitor and optimize the performance of the database.
