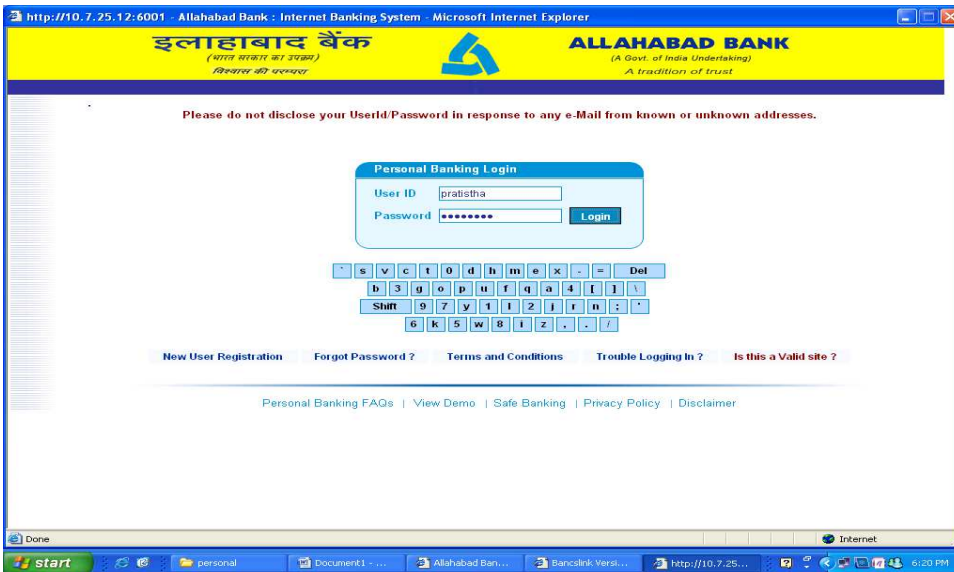

1. The user has to log into the Allahabad Bank Internet Banking through the following URL

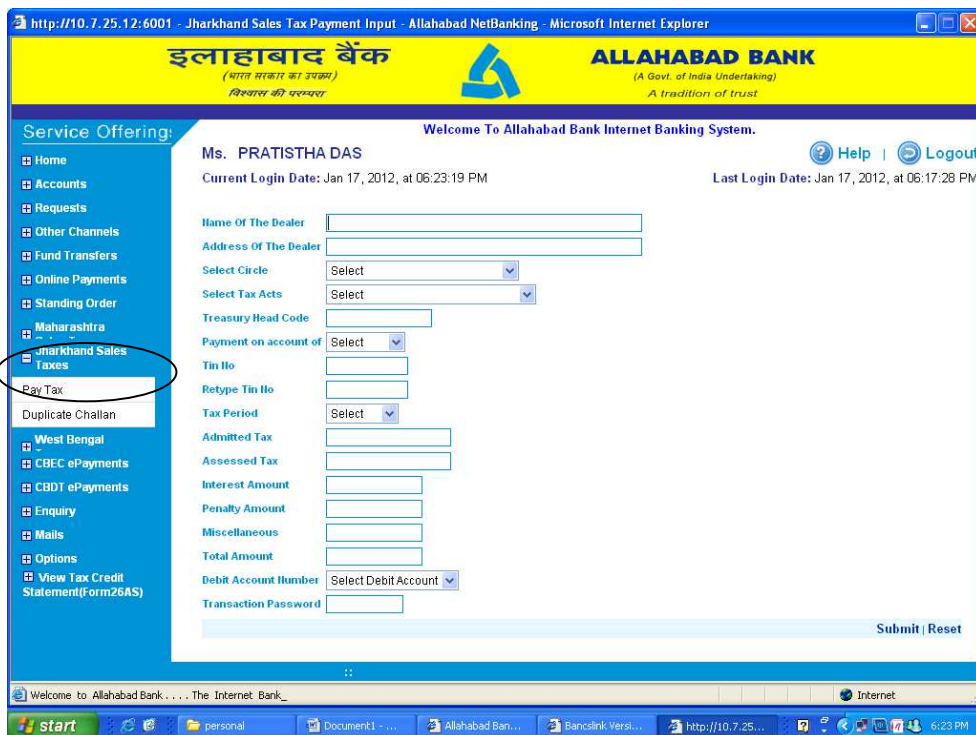

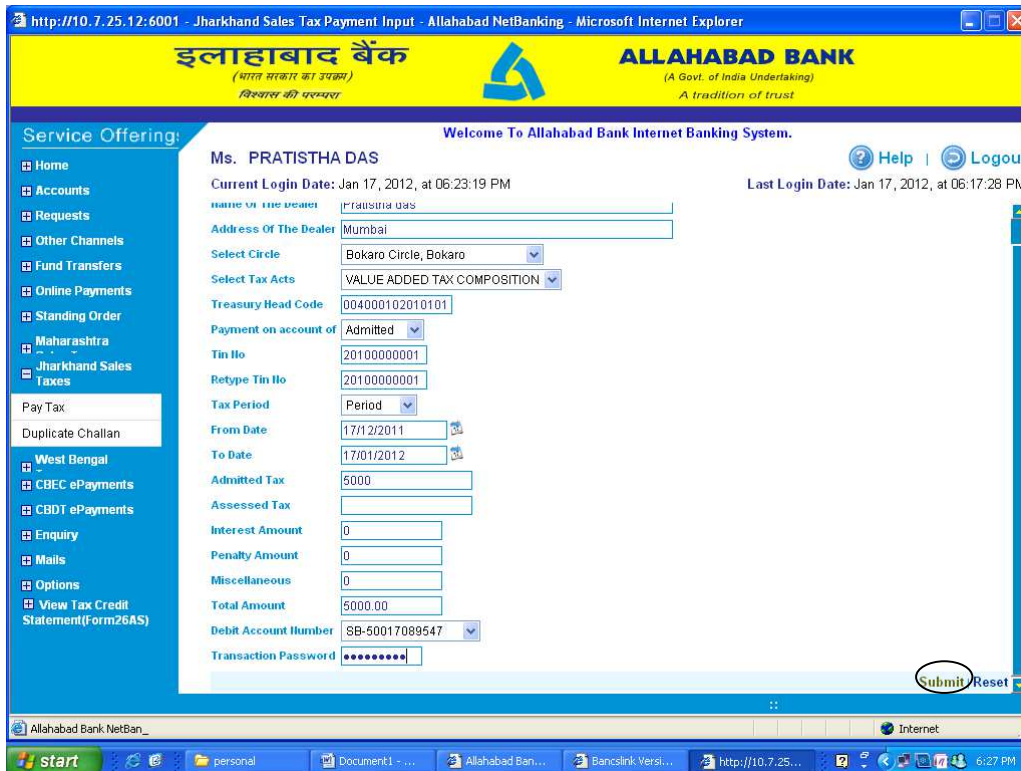
Individual customer has to log in through **Personal Banking** and Corporate users have to log in through **Corporate Banking**



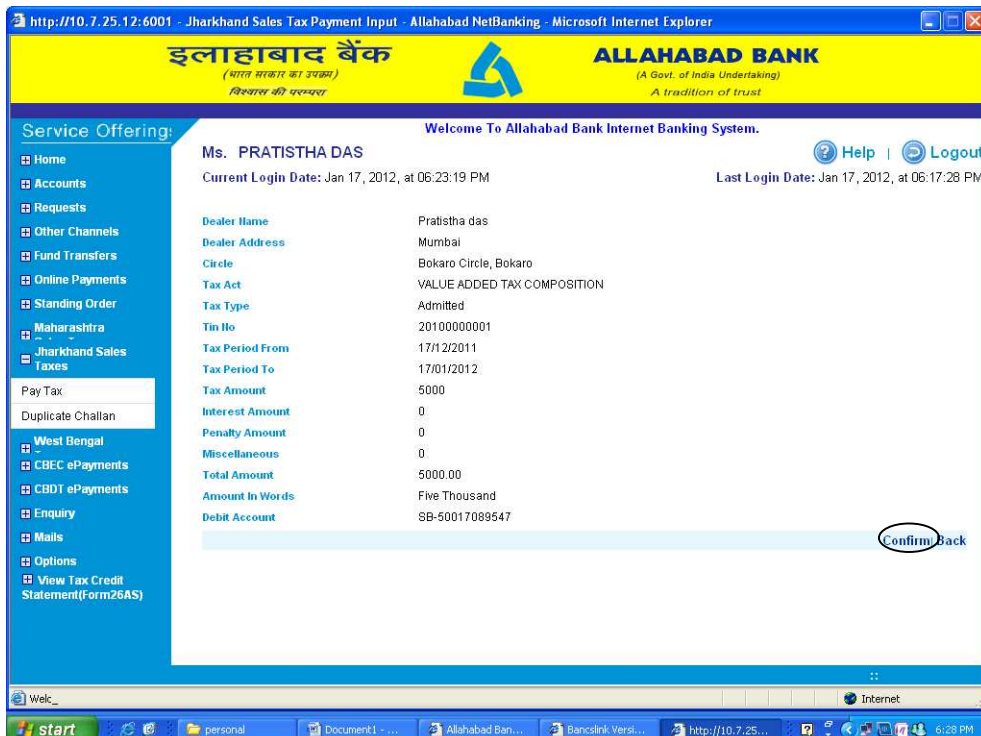
2. Go to Jharkhand Sales Tax Menu → Pay Tax
